Community Health Assessment



- 10 community focus groups, Spanish and English, urban and rural
- PhotoVoice: 15 local photographers, two public exhibits and interactive-voting displays



- Community Health Needs Assessment information sharing
- Community Partner Input Meeting



- 600 WIC participant surveys
- 700 community surveys at Safe Kids Day and weeklong anniversary celebration
- 10 key stakeholder interviews
- Data gathering, comparison, document composition and public presentations

Impact: Identified community needs, improved partner relationships which will set the course for a Community Health Improvement Plan, reinforced funding requests and focused our services.


Public Awareness Campaign

- Focus group findings showed people were aware of public health services but not clear about who provides them in our community.
- In April, we celebrated National Public Health Week and Safe Kids Day.
- Looking for a way to involve more people in these activities and use them to benefit our Community Health Assessment, staff created:
 - a weeklong celebration of our 10th anniversary "on the corner of 23rd & Adams" with one day devoted to each division.
 - a survey for general public and partners asking, "What are your top 3 public health priorities?"



Impact: Highlighted public health services and brought a diverse mix of regular customers and general public into the Community Health Assessment.

Nurse Family Partnership



Funding became available for evidence-based nurse home visitation program that improves the health, well-being and self-sufficiency of low-income, first-time parents and their children by establishing long-term relationships between public health nurses and families.

- May hired and trained staff
- June visits began
- July hosted community meeting with schools, hospitals, partner agencies

Impact: 71 qualified first-time mothers enrolled, 35 babies born

Immigration Exams



A two-part medical examination is required for all individuals applying for admission and citizenship in the United States.

- blood work
- vaccinations
- health history
- radiological services
- Physical exam with a Civil Surgeon, a licensed doctor who is certified to provide immigration physicals with the United States.

Impact: Nearly 70 new immigrants completed the exams in our first year of implementation.

Hepatitis C Drug Diversion Exposure



Routine Investigation

• Long-time blood donor with newly identified Hepatitis C infection. Concern of exposure through healthcare setting. 5 healthcare facilities evaluated for breach in infection control practices or other exposure concerns.



UDOH Incident Command

• Link found to healthcare worker with matching genotype under corrective action from DOPL for drug diversion. UDOH, 2 local hospitals and LHD's start a contact investigation to determine if further spread.



Impact

• 7,217 contacts notified and offered testing. 3,742 are WMHD residents. 45.8% of all contacts tested with 16 associated cases found. WMHD investigates 13 of these cases, plus 17 non-associated Hep C cases identified through investigation.


Classes Tailored to Audience's Needs with Fidelity to Each Curriculum

Impact: Program reached more youth than ever before expanding the number of contacts by 17 %

WIC Works to Reduce Iron Deficiency in Kids

- WIC nutritionists educated and provided handouts to parents of 1-year-olds
- Put up a bulletin board in classroom
- Incorporated message in each class taught.
- Low hemoglobin levels typically indicate children are not consuming enough iron or absorbing the iron in their diets. Low hemoglobin levels can impede growth and learning abilities.

Impact: Rates dropped 2.58 percent



WIC Wins Preparedness Challenge

Keeping staff motivated throughout the 12-month Hunger Games Challenge was a priority.

- Reminder emails were sent to every employee whether they participated or not
- Monthly prize drawing for active participants
- Top prizes were fully stocked 72-hour kits for each member of the team with the most participation



Impact: WIC won the interdepartmental competition with 100% participation. Overall, 47% of the staff completed the challenge.

Mayor's Walk, a New Tradition



In partnership with Ogden City, our Environment, Policy and Improved Clinical Care Program helped sponsor a new event with the Ogden City Marathon.

- 1-mile non competitive walk with Ogden City Mayor Mike Caldwell
- Anyone could sign up to participate
- Ogden City and WMHD staff reached out to community recreation and senior centers to recruit participants

Impact: While only about 100 people joined in the inaugural walk, we feel this event will grow and the health department tie in shows that physical activity can be for everyone.

Revamping Smoking Vehicle Program

Legislative changes gave DMV authority to revoke vehicle registrations based on emissions violations.


- Worked with surrounding counties and the state to develop a consistent protocol for when vehicles are reported to the health department.
- Took a two-tiered approach
 - Reports from the public result in an educational letter to vehicle owner.
 - Reports from staff or law enforcement resulted in a request for an inspection at facility where vehicle is registered.
 - Vehicles that aren't repaired are referred to DMV for registration revocation.

Impact: An additional tool to help reduce vehicle emissions

Community Liaison Program

The Leadership Team initiated a Community Liaison Program as outlined in the WMHD Strategic Plan.

- Introduced new health director to city and county officials
- Brought a staff member who lives in that community
- Included other staff most likely to interact with on the job
- Discussion topics included:
 - Public health achievements, responsibilities
 - Seasonal air quality messages
 - Findings from the Community Health Assessment
 - Ongoing projects or recent interactions within that community
 - Provided pamphlets of services, programs and points of contact




Impact: Director Bennion and various staff members visited 7 cities and both commission/council meetings in each county. The remaining cities will be completed in 2016.
