Commissioner Dearden moved to approve the consent items; Chair Zogmaister seconded, both voting aye.

## E. ACTION ITEMS

1. Consideration to waive penalty and/or interest on 2010 taxes, land serial number 04-016-0019

Brenda Wheelwright, County Treasurer's Office, stated that Doug Bassett co-owns multiple housing property on Brinker Avenue and his property manager had told him he would pay the 2010 property taxes. This did not occur. Mr. Bassett came to the County Treasurer's Office to pay his property taxes on 2/1/2010 and was told that as of 2/1/10 the late penalty had increased from 1% to 2.5% and there was also accrued interest. Mr. Bassett paid the 2010 taxes but not the penalty or interest.

Mr. Bassett stated today that he has paid taxes timely every year. He fired the property manager who had assured him the taxes had been paid. He had not been able to come to the county on November 30 to pay the 2010 taxes.

Chair Zogmaister noted there had been no error by the county regarding this property. Commissioner Dearden moved to uphold the Tax Review Committee's recommendation not to waive penalty and/or interest on 2010 taxes, LSN 04-016-0019; Chair Zogmaister seconded, both voting aye.

## **G. Public Comments**

(See related public comments, minutes, 3/1/11.) Lynnette Penrod, Weber County resident, stated that Representative Brad Dee's legislation, H.C.R. 18, a Concurrent Resolution Approving Solid Waste Facility Classification Change, is now on the senate's calendar to approve a second reading. She is of the opinion that this proposed legislation should be derailed, that it is not good legislation, and that Weber County should not let it get passed. Ms. Penrod felt that the Commission was not well informed. She asked the Commission to explain why it is a good idea for Weber County citizens to spend over \$1 million to purchase and develop the landfill and why the county should only get 8 cents out of every dollar and the operator keep 92 cents. She said that it is the duty of the Commission to get other political entities to help contribute to the cost of building the landfill if the county is going to accept waste from outside the county. She said she felt this commercial permit moved forward without input from Weber County citizens.
