MINUTES WEBER COUNTY COMMISSION

D. COMMISSIONER COMMENTS:

Chair Bolos: I wanted to take a moment to read a letter the Attorney's office received from Riverdale Police Chief Casey Warren:

Weber County Attorney's Office- Investigator Steve Haney, Investigator Steve Zaccardi, Investigator Cameron Hartman, Attorney Nicholas Caine, Attorney Derek Malan, and Victim Advocate Jamie Pitt.

On March 24, 2025, at approximately 2:45 PM, the Riverdale Police Department and Riverdale Fire Department were dispatched to 5100 South 1050 West in response to reports of a structure fire. Upon arrival, officers observed smoke coming from a trailer. They gained entry and discovered an unresponsive woman inside. Officers carried the woman to safety, but despite efforts to provide medical aid, she was unfortunately pronounced deceased at the scene.

Further investigation revealed that two small children were missing, along with the suspect—identified as their father, Ricardo Trujillo. An AMBER Alert was promptly issued. Thanks to the coordinated efforts of law enforcement, the children were safely located, and the suspect was taken into custody.

Investigators Steve Haney, Steve Zaccardi and Cameron Hartman with the Weber County Attorney's Office responded to the scene and provided critical support throughout the investigation. Their experience and expertise were instrumental in advancing the case and ultimately bringing the suspect to justice. Both investigators worked seamlessly alongside the Riverdale Police Department, ensuring a smooth and effective investigative process.

Weber County Attorneys Nicholas Caine and Derek Malan, along with Victim Advocate Jamie Pitt, also responded to the scene. Their early involvement and ongoing commitment to the case will be invaluable as the investigation concludes and prosecution proceeds.

All members of the Weber County Attorney's Office demonstrated exceptional professionalism and dedication throughout the investigation. Their contributions were vital in supporting the Riverdale Police Department and securing the arrest and charging of the suspect with Aggravated Murder.

I thought that was a great synopsis of our County Attorney's office support in that horrible crime committed in Riverdale. I appreciate that letter from Chief Warren.

F. PRESENTATIONS:

1. Presentation of a Proclamation declaring April 21-28, 2025 as International Dark-sky Week in Weber County.

Commissioner Harvey: I want to give special recognition to Sara Toliver from Visit Ogden who helps keep us focused. I also want to thank Ron Gleason and Zach Thomas, as well as Marty Smith and Todd Ferrario from our Culture, Parks, and Recreation department who help us comply with this Dark Sky rating. The dark skies across the County are very important and we have an area east of our mountains that we make sure to preserve that Dark Sky class rating. The Proclamation today is about maintaining our important Dark Skies accreditation. The Proclamation reads as follows:

WHEREAS, the aesthetic beauty and wonder of a natural night sky is a shared heritage of all humankind; and

WHEREAS, the experience of standing under a starry night sky inspires feelings of wonder and awe, encouraging a growing interest in science and nature, particularly among young people and visitors from outside the local communities.; and

WHEREAS, light pollution has scientifically established economic and environmental consequences, which result in significant impacts on the ecology and human health of all communities; and 80 percent of the world's population, including most people in Weber County, lives under a dome of light pollution and may never experience the visual wonder of living under a dark sky; and

WHEREAS, light pollution represents a waste of natural resources amounting to roughly \$3 billion per year of wasted energy in the United States and contributes to diminished energy security; and

WHEREAS, Weber County is home to North Fork Park, the 21st International Dark Sky Park. North Fork Park is a destination for people who seek out the best, darkest skies. Astronomers and local organizations host star parties, eclipse viewing, and other dark sky events that draw locals and tourists to North Fork Park, and

WHEREAS, astrotourism not only provides an awe-inspiring experience but also brings significant economic benefits to Weber County. By attracting stargazers and astronomy enthusiasts, dark skies in Weber County boost local tourism, encourage longer stays, and increase spending in communities near North Fork Park. Additionally, astrotourism promotes environmental awareness and conservation efforts, ensuring that future generations can continue to enjoy the beauty of the night sky, and

WHEREAS, North Fork Park is home to dozens of nocturnal wildlife species—including several species of bats, owls, and rodents such as mice and voles—and these species rely on undisturbed night environments to hunt, mate, and thrive; and

WHEREAS, DarkSky International, the globally recognized authority on light pollution, recognizes International Dark-Sky Week to raise awareness of the effects of light pollution, provide free education, resources, and solutions to the public, and encourage the protection of and enjoyment of dark skies and responsible outdoor lighting.

Now, Therefore, The Weber County Commissioners, do hereby declare April 21 - 28, 2025 as INTERNATIONAL DARK-SKY WEEK in Weber County, Utah and ask each resident to join us not only in observing and pondering upon this important week but also in raising awareness and support for protecting our precious dark sky as a resource.
