**F. ACTION ITEMS:**

- 1. **INTERLOCAL AGREEMENT WITH MARRIOTT-SLATERVILLE CITY TO DEFINE TERMS RELATED TO PARTICIPATION IN A COMMUNITY DEVELOPMENT PROJECT AREA PLAN AND COMMITMENT OF TAX INCREMENT FINANCING – CONTRACT C2015-156**

Douglas Larsen, Weber County Economic Development Partnership Director, cited critical components from the Marriott-Slaterville Community Development Project Area Plan: Development of an approximately 43-acre parcel at the northwest corner of 12<sup>th</sup> Street and I-15 into a commercial center intended to provide retail products and services to the public, bringing with it roughly 35-50 jobs. Marriott-Slaterville is asking the county's participation to facilitate investment primarily for infrastructure. Marriott-Slaterville is requesting that the county provide a portion of the new property tax revenue that will be generated by this development for a 15-year period at a rate of 65%. Currently, the county receives \$105/year from this 43-acre parcel. Mr. Larsen noted that at \$1 million of increased value, it would generate \$3,300/year and at \$10 million in increased taxable value, it would be \$33,000-\$34,000/year. Based on current rates, and the proposed participation rate, the county would receive 35% of the new generated tax, and at \$10 million (in increased taxable value) that would be roughly \$11,000/year. Additionally, as a taxing entity the county is not receiving sales tax revenue from this property, and at the advertised sales volume of \$50 million/year it would be nearly \$150,000 annually just for the county's general sales tax portion. If there is no increase in value, or the project does not come to fruition, the county does not lose anything. He said that Marriott-Slaterville anticipates initial investment of about \$15 million and estimates about \$50 million in annual retail sales. He addressed Commissioner Bell's question stating that this request is for property tax only. Marriott-Slaterville is participating with 65% of its new sales tax revenue.

Commissioner Ebert moved to approve Contract C2015-156, Interlocal Agreement with Marriott-Slaterville City to define terms related to participation in a Community Development Project Area Plan and commitment of tax increment financing; Commissioner Bell seconded.
