Charlie Ewert (Planning): Resolution to change the General Plan to change Park and Open Sopace designation to large residential ... And there is a Development Agreement for Winston Park that includes \$7500 per lot and a 12 foot wide trial easement to ... There is an Ordinance to rezone from A-1 to R1-15 zone. ...

Wade Rumsey, Idaho Falls, ID: As we explained with the park donation, we prefer the \$5k per lot. We hope you would take that under consideration. We ... think we can make that land easement happen for... Thank you.

Commissioner Bolos: I asked about outreach to the property owners bordering what should be the park.

Mr. Ewert: The applicant has reached out to some of the owners. The CCRs for Phase 1 contained language that adjacent properties in future phases would be developed.

Commissioner Bolos: I am not going to agree until all property owners are notified.

Commissioner Froerer: I know the developers had an agreement with the Park District for the \$5k per lot. Any ... ?

Mr. Ewert: One caviat to the \$7500 per lot is if they build less than 1k square feet...

Chair Harvey: Trail access but not a road?

Mr. Ewert: Yes, a road

Chair Harvey: I need three things for approval. All neighbors notified. %7500 per lot. And road access to the west.
