Request verbiage be added to description and definitions in proposed policy changes that limit government from making requirements to health choices.

4. APPROVAL OF A CONTRACT WITH WEBER STATE UNIVERSITY CAMPUS RECREATION FOR ICE LEASE FOR THE 2021-2022 SCHEDULED HOME GAMES AND PRACTICES.

Mariko Rollins (Ice Sheet) explained this a basic lease agreement with indemnity updates and a tryout clause not used previously.

5. Request for approval of a contract by and between Weber County and Liberty Broadband, LLC, to set up a partnership in applying for a grant from the National Telecommunications and Information Administration.

Bryan Baron (Attorney) provided background on this contract and how it covers moving forward with grant application with allowance for backing out if the project is not viable or in the best interest of the county.

Lt. Courtney Ryan (Sheriff's Office) shared that medical field using this technology for a long time. Cuts down time writing reports and increases safety. Three year contract for \$30k lease in lieu of \$100K purchase.

Chairman Harvey: Who owns data once it is recorded?

Mr Ryan: Weber County. Data goes directly to report management system and not into Dragon/Nuance's cloud.
