1. CONTRACT WITH LANDSLIDE TECH, DIVISION OF CORNFORTH CONS INC., FOR GEOTECHNICAL SERVICES FOR OLD SNOWBASIN ROAD - CONTRACT C2012-182

Michael Tuttle, of County Engineering, presented this contract, which is related to Contract C2012-169. UDOT will pay the contractor and the county will reimburse UDOT for its match of 6.77% (\$8,115.25).

Commissioner Zogmaister moved to approve Contract C2012-182 with Landslide Tech, Division of Cornforth Cons Inc., for geotechnical services for Old Snowbasin Road; Commissioner Gibson seconded, all voting aye.

E.5. - TAX REVIEW BOARD'S RECOMMENDATION REGARDING LSN 22-149-0003

Machel Maycock, of the County Assessor's Office, noted that the petitioner, Leslie Rodriguez, requested review of a factual error and refund for the past 8 years on the Rodriguez' Liberty home relating to incorrect square footage of 3,408. The actual square footage is 2,395. The Tax Review Committee (Committee) approved a refund for 2011, however, the petitioner did not file a timely appeal for prior years (2004-2010) and the Committee recommended denial of the request. This is also consistent with the Commission's actions on similar prior requests.

Ms. Rodriguez said that due to a recent appraisal of their home it was brought to their attention that the county had the incorrect square footage. They contacted the county which corrected the error on 7/2012 for tax year 2011.

Joe Olsen, of the County Assessor's Office, addressed the Commission's question stating that anything that adds or detracts from property value is considered when assessing. He said that an area of this property was calculated twice, resulting in a factual error. Commissioner Zogmaister reiterated that it is the property owners' responsibility to ensure their property information is correct. This issue will be submitted for reappraisal for 2013.

Commissioner Zogmaister moved to accept the Weber County Tax Review Committee's recommendation and deny the request for a refund on land serial number 22-149-0003; Commissioner Gibson seconded, all voting aye.
