MINUTES OF THE BOARD OF COMMISSIONERS OF WEBER COUNTY

D. Presentation of the Interim Financial Report as of June 30, 2014

Scott Parke, County Comptroller, noted that State law requires the county budget officer to present a condensed statement on the financial status of the county at a Commission meeting at least once per quarter. In the past this information has been available on the transparency website but has not been formally presented. This report included the original budget figures, the actual budget as of 6/30/2014, and the percentages for the current year and for the prior year. There is nothing of particular concern. He addressed Commissioner Zogmaister's question noting that the significant change column highlights a large swing from the prior year.

F. ACTION ITEMS:

1. RATIFY A CONTRACT WITH BLX GROUP LLC FOR ARBITRAGE REBATE COMPLIANCE SERVICES – CONTRACT C2014-191

Scott Parke, County Comptroller, stated that this is a standard contract relating to the IRS requirement on calculating arbitrage and rebate on outstanding bonds, and it occurs every fifth year. Commissioner Zogmaister moved to ratify a contract with BLX Group LLC, Contract C2014-191, for arbitrage rebate compliance services; Chair Gibson seconded, both voting aye.

2. CONTRACT WITH BUCK CONSULTANTS FOR AN ACTUARIAL STUDY ON THE COUNTY'S OTHER POST EMPLOYMENT BENEFITS – CONTRACT C2014-192

Scott Parke, County Comptroller, stated that actuaries are hired to perform a valuation every other year of the retiree health insurance benefits for the current and future retirees. He stated that the fees charged by Buck are in line with those they charged two years ago and the county is pleased with their work.

Commissioner Zogmaister moved to approve Contract C2014-192 with Buck Consultants for an actuarial study on the county's other post employment benefits; Chair Gibson seconded, both voting aye.

3. Memorandum of Understanding with Ogden City Animal Services for animal Licensing services – Contract C2014-193

Scott Parke, County Comptroller, presented this contract for Lt. Chad Ferrin, who was not present. He stated that the contract allows the county to license animals for the Ogden shelter and the county charges a fee of \$2/animal for this service.

Commissioner Zogmaister moved to approve Contract C2014-193, Memorandum of Understanding with Ogden City Animal Services for animal licensing services; Chair Gibson seconded, both voting aye.

4. Final approval of Phase 1 of The Ridge Townhomes at Wolf Creek PRUD, 8 units, a condominium project at approximately 3400 North Moose Hollow Drive including a financial guarantee for subdivision improvements for \$591,204.01

Jim Gentry, of the County Planning Division, stated that this item is for approval of 8 units of a 48-unit development. The Planning Commission unanimously recommended approval.

Commissioner Zogmaister moved to grant final approval of Phase 1 of The Ridge Townhomes at Wolf Creek PRUD, 8 units, a condominium project at approximately 3400 North Moose Hollow Drive with a financial guarantee for subdivision improvements for \$591,204.01; Chair Gibson seconded, both voting aye.
