**5. COOPERATIVE AGREEMENT WITH THE UTAH STATE UNIVERSITY EXTENSION SERVICE FOR A NEW CONTRACTED FINANCE EDUCATOR POSITION – CONTRACT C2015-371**

Christopher Crockett, Deputy County Attorney, presented this contract renewal outlining the significant change, which is that it will be a 4-year rather than a 1-year contract. It now includes a provision allowing the parties to terminate the contract upon 60 days notice. Commissioner Ebert noted that there is no change to the annual cost.
