E. ACTION ITEMS:

1. **ACTION ON A LEGISLATIVE AMENDMENT TO THE OGDEN VALLEY GENERAL PLAN; OGDEN VALLEY PATHWAY MASTER PLAN AND MASTER PLAN MAP – RESOLUTION 25-2013**

The Ogden Valley General Plan was adopted in 1998 and amended in 2002 to include the Ogden Valley Pathway Master Plan and Map. In 2009 the county was a leader in collaborating with Weber Pathways, all 15 municipalities in the county, along with federal, state and regional agencies to create the Weber County Cooperative Pathways Master Plan and making this project a reality.

The County Commission held a public hearing on this item on 10/1/2013 and it was tabled. Citizens raised a concern with language in the General Plan that allowed the appendix of proposed pathways to be updated without a General Plan amendment. This issue was subsequently reviewed with the county's legal counsel and it was decided to eliminate the sentence that stated, "It is intended to be updated without a General Plan amendment."

The ad hoc committee, staff and the Ogden Valley Planning Commission recommend approval.

Today the Commission approved the amendments to the Ogden Valley Master Plan and Map so that they are consistent with the Weber County Cooperative Pathways Master Plan, striking the above noted language.

Commissioner Zogmaister moved to adopt Resolution 25-2013 adopting amendments to the Ogden Valley Pathway Master Plan and Master Plan Map; Commissioner Bell seconded.
