Scott Parke (County Comptroller): 1.5% COLA, up to 2% pay-for-performance for executive officers like the regular employees, Health Department's compensation determined by Board of Health.

Commissioner Bolos: ... And can you confirm the health insurance increase of 15% compared to the final 9.7%?

Mr. Parke: They originally wanted to increase up to 15% as they are paying out more than they collect from the County. We took bids from other providers and our existing provider came back with the offer we accepted at just below a 10% increase.

- James Ebert, Farr West: I want to express appreciation for compensating our leaders to help keep them on the team. I also want to make sure there are no General Fund money being used for enterprise services... And I agree with the Mayor that...
