

Record of the County Court of Weber County, Utah Territory.

March 3.

East Quarter of the South East Quarter of Section Twenty Eight (28) Township Seven North, of Range One West, Salt Lake Meridian known and designated as Weber County Survey Monument No. 44 - running from thence North 60.00 chains to the Northeast corner of said section and to the intersection of the center of a road leading Westward to Pleasant View, thence continuing North 240.00 chains to the Northeast corner of Section Nine, in the above named Township and Range, said road being 300. chains in length.

Description of a County Road four rods wide running Westward from the North East corner of Section Twenty Eight Township Seven North, of Range One West, Salt Lake Meridian, situated North from North Ogden District.

21. Beginning at the Northeast corner of Section Twenty Eight (28) in Township Seven North, of Range One West, Salt Lake Meridian, and running from thence West 40.00 chains, on the North line of said section to the intersection of the center of a road four rods in width running North from North Ogden to the mountains, thence continuing West 127.39 chains on the North line of Sections Twenty Eight (28) Twenty Nine (29) and Thirty (30) Township Seven North, of Range One West, Salt Lake Meridian and to the intersection of the center of a road four rods in width leading Northward from Pleasant View to Pole Patch. Said road being 167.39 chains in length from its beginning to this point.

Description of a County Road four rods wide leading Northward from North Ogden, to the mountains.

22. Beginning at a certain monument of sandstone situated at the South East corner of the North East Quarter of the South East Quarter of Section Twenty Eight (28) in Township Seven North of Range One West, Salt Lake Meridian known and designated as Weber County Survey Monument No. 44, running from thence West 40.00 chains, thence North 20.00 chains to the center of said Section Twenty Eight (28), thence continuing North 40.00 chains to the North line of said section, and to the intersection of a road four rods in width leading Westward to Pleasant View District - thence continuing North 240.00 chains, and to the North line of Section Nine, Township Seven North of Range One West, Salt Lake Meridian. Said road being 340.00 chains in length from its beginning to said termination.

Description of a County Road four rods wide leading Eastward through the Northern portion of North Ogden.

23. Beginning at a certain monument of sandstone situated in the center of Main Street 100 chains

Weber County, Utah.

At a session of the County Court of Weber County, in the Territory of Utah, held on the 3rd
 day of March A. D. 1885 (the minutes of the proceedings of which are recorded in County Book
 C on page 367-8 &c.) the following described road was declared to be a County Road, to-wit:

Northward from North Ogden: -

Beginning at a certain Monument of Sandstone situated on the southeast corner of the Northeast Quarter of the Southeast Quarter of Section 28, Township 7 North of Range One West - Salt Lake Meridian - known and designated as Weber County Survey Monument No. 44 running from thence North 60 chains to the northeast corner of the said section, and to the intersection of the center of a road leading Westward to Pleasant View, thence continuing north 240 chains to the northeast corner of Section 9, in the above named Township and Range. Said road being 300 chains in length.
