The length of said road being 244.52 chains.

Description of a County Road four rods wide leading Northward from Plain City intersecting the boundary line of Heber County, West from the Hot Springs.

36. Beginning at a point in the center of the street leading from Plain City to the Hot Springs 11.12 chains due East and 11.42 chains N.  $0^{\circ} 27' E$ . from the South West corner of Section No. Twenty Eight, Township Seven North, of Range Two West, Salt Lake Meridian, running from thence N.  $0^{\circ} 27' E$ . 12.17 chains, thence N.  $10^{\circ} 50' E$ . 15.50 chains, thence N.  $27^{\circ} 10' E$ . 9.95 chains, thence N.  $31^{\circ} 47\frac{1}{2}' E$ . 58.50 chains, thence N.  $25^{\circ} 56' E$ . 82.50 chains, and to the Northern boundary line of Heber County. Description of a County Road four rods wide leading Southward from Ogden City to Uintah District.

37. Beginning at a certain monument of sandstone situated in the center of Main Street at the South end of Ogden City 12.16 chains West and 11.89 chains North from the South East corner of the North East Quarter of Section Five, Township Five North of Range One West, Salt Lake Meridian, known and designated as Weber County Survey Monument No. 48 "South end of the Weber County Base" <sup>with dimensions 8" x 18" x 48"</sup>. The bearings from said monument are as follows, to Observatory Peak N.  $89^{\circ} 52' E$ , to Benlonsont Peak N.  $2^{\circ} 08' E$  to the spire on the Weber County Court House N.  $2^{\circ} 49' E$ , and to the U. S. Observatory N.  $11^{\circ} 3^{\circ} 04' N$ . running from thence S.  $56^{\circ} 48' E$ . 15.02 chains, thence S.  $44^{\circ} 34' E$ . 9.37 chains, thence S.  $89^{\circ} 45' E$ . 13.11 chains to Monument No. 49, situated near the Pleasant View Cemetery in Ogden City thence S.  $0^{\circ} 15' N$ . 40.01 chains, to the South line of Section No. Five, Township Five North of Range One West, Salt Lake Meridian, thence East 1.38 chains to Monument No. 50, thence S.  $17^{\circ} 47' E$ . 12.39 chains, thence N.  $89^{\circ} 06' E$ . 6.42 chains, thence North 1.00 chain, thence N.  $88^{\circ} 49' E$ . 20.58 chains, thence S.  $74^{\circ} 24' E$ . 6.79 chains, thence S.  $61^{\circ} 35' E$ . 5.72 chains, thence S.  $40^{\circ} 38' E$ . 9.42 chains, thence S.  $88^{\circ} 28' E$ . 10.58 chains, to Monument No. 51. ## Weber County, Utah.

At a session of the County Court of Weber County, in the Territory of Utah, held on the 3rd  
 day of March A. D. 1885 (the minutes of the proceedings of which are recorded in County Book  
 on page 376-7 &c.) the following described road was declared to be a County Road, to-wit:

Running north from Plain City intersecting County line.  
 Beginning at a point in the center of the street leading  
 from Plain City to the Hot Springs, 11.12 chains due east and  
 11.42 chains N. 0° 27' E. from the southwest corner of Section <sup>No. 28</sup>  
 Township 7 North of Range 2 West, Salt Lake Meridian, brown  
 mining from there with the 0° 27' E. 12.07 chains, thence the  
 N. 0° 50' E. 45.50 chains, thence N. 27° 10' E. 9.95 chains,  
 thence N. 31° 47' E. 58.50 chains, thence N. 26° 56' E. 82.50  
 chains, and to the northern boundary line of Weber County  
 The bearings from said point being as follows: - to Eyrie  
 Peak S. 68° 34' E., to the chimney on the North Ogden  
 Meeting House S. 78° 05' E. and to the chimney on the  
 south end of the Hot Springs Hotel N. 63° 07' E. The  
 total length of said road is 178.62 chains.
