

August 1, 1889. South $89^{\circ} 53'$ East $2^{\circ} 59'$ chains, along the North line of said Section, thence South $1^{\circ} 38'$ chains, along the East line of the West $1/2$ of the North East Quarter of said Section, ^{and} intersecting the center line of the County Road leading from West Weber District to Ogden, as heretofore adopted, by ^{and} the same is hereby designated as, ^{and} declared to be a County Road ^{and} public highway.

On motion of Mr. Childs

It was Ordered, That all that portion of the County Road heretofore surveyed ^{and} adopted, which is described as follows, by ^{and} the same is hereby discontinued ^{and} abandoned, to wit: Beginning at a point 12 chains North ^{and} $50/100$ of a chain East from the South West corner of Section 15, in Township 5 North of Range 2 West of the Salt Lake Meridian, W. S. Survey, ^{and} running thence East 159 chains, along the center of said road or street, to a point $50/100$ of a chain West of the East line of Section 14, in said Township ^{and} Range, ^{and} intersecting the West line of the County Road leading from Ogden City, through Pivardale, to Salt Lake City.

On motion of Selectman Childs,

It was Ordered, That all that portion of the land described as follows, by ^{and} the same is hereby designated as and set apart to be a County Road or public highway to wit: Beginning at the South West corner of Section 15, Township 5 South of Range 2 West of the Salt Lake Meridian, W. S. Survey, ^{and} running thence East 160 chains, along the center of street, ^{and} along the South line of said Section 15 ^{and} 14, in said Township ^{and} Range, to the South East corner of said Section 14, ^{and} intersecting the center of the main County Road leading from Ogden City, through Pivardale, to Salt Lake City. The following claims were presented, read, allowed and ordered paid out of any money in the Treasury not otherwise

County Road Book,

At a session of the County Court of Weber County, in the Territory of Utah, held on the 7th
 day of August A. D. 1889 (the minutes of the proceedings of which are recorded in County Book
 Co. on page 128 &c.) the following described road was declared to be a County Road, to-wit:

It was ordered that all that portion of the land described as follows, be, and the same is hereby designated as and set apart to be a County Road or public highway, to-wit: - Beginning at the Southwest Corner of Section 15, Township 5, North of Range 2 West of the Salt Lake Meridian, U. S. Survey, and running thence East 160 chains, along the center of street ~~and along the center of street~~, and along the south line of Section 15 and 14, in said Township and Range to the southeast corner of said Section 14, and intersecting the center of the Main County Road, leading from Ogden City through Riverdale, to Salt Lake City.
