#### RESOLUTION Roadway Abandonment Portion of State Route 60

WHEREAS, Section 27-12-102 of the Utah Code Annotated, 1953, authorizes the Transportation Commission to abandon highway sections no longer serving the purpose of a public roadway, and

WHEREAS, that portion of State Route 60 from State Route 89 east to former State Route 49, a distance of 0.45± mile, in South Weber, Davis County, has been maintained by South Weber City, and

WHEREAS, South Weber has no further use of the subject road and recommends abandonment by the Transportation Commission,

NOW, THEREFORE, be it resolved that the portion of State Route 60 (7400 South in South Weber) from State Route 89 east to former State Route 49, as shown on the accompanying map sheet, be abandoned to the adjacent property owner(s).



# DECLARATION OF ABANDONMENT

# Abandonment of Relinquished Right-of-Way On a Realigned Section of Old SR-60 near South Weber City Project No \*NH-0089(30)346 In Davis County

WHEREAS, Section 72-4-104 of the Utah Code 1998, Provided for the Disposition of Highways Realigned. (2b) abandoned by the department if it no longer serves the purpose of a highway, and

WHEREAS, the roadway which operated as a portion of old SR-60 was never officially abandoned when new alignment in conjunction with Project No. \*NH-0089(30)346 was completed, and

WHEREAS, the Region One Director has indicated that the Deputy Director of the Utah Department of Transportation acting in the best interest of the Utah Department of Transportation should officially abandon the old roadway described herein, and

WHEREAS, the Director of Right of Way has reviewed the situation pertaining to stated old right-of-way and concurs with the Region One Director that the portion of old SR-60 described herein, should be officially abandoned, and

WHEREAS, the appropriate staff of the Transportation Planning Division having reviewed all the material pertaining to stated abandonment concur with the Region One Directors recommendation.

NOW THEREFORE, be it resolved as follows:

1 Right-of-Way of old SR-60 being described as follows:

#### Parcel Q1

A parcel of land, being part of an entire tract of property situate in the South ½ of Section 26 and the North ½ of Section 35, Township 5 North, Range 1 West, S.L.B.&M. The boundaries of said parcel of land are described as follows:

Beginning at the north Quarter corner of said Section 35; and running thence S.00°32'23"W. 33.00 feet (10.058 meters) along the Quarter Section line to a point on the southerly right-of-way of the former South Weber Drive (SR-60); thence N. 89°27'36" W. 1374.30 feet (418.886 meters) parallel with the north line of said Section 35 to a point of intersection with a non-tangent 731.95-foot (223.098-meter)radius curve to the left; thence northwesterly 215.45 feet (65.681 meters) along the arc of said curve, chord bears N.71°33'20"W. 214.67 feet (65.431 meters) to a point on the northerly right-of-way of the former South

Weber Drive, said point being 42.98 feet (13.100 meters) radially distant northeasterly from the centerline of said South Weber Drive; thence S.89°27'36"E. 1578.21 feet (481.038 meters) along said northerly right-of-way line to the Quarter Section line; thence S. 0°03'29" W. 33.00 feet (10.058 meters), to the point of beginning. The above described tract of land contains 96300 square feet, or 2.211 acres in area.

#### Parcel Q2

A parcel of land, being part of an entire tract of property situate in the South ½ of Section 26 and the North ½ of Section 35, Township 5 North, Range 1 West, S.L.B.&M. The boundaries of said parcel of land are described as follows:

Beginning at a point on the northerly right-of-way of the former South Weber Drive (SR-60), said point being 33.00 feet (10.058 meters) N.00°03'29"E. along the 1/4 section line from the north Quarter corner of said Section 35; and running thence along said northerly right-of-way line parallel with the north line of said Section 35, S.89°27'37"E. 2486.08 feet (757.757 meters) to a point which is 140.00 feet (42.672 meters) perpendicularly distant westerly from the center line of US-89, Project No. \*NH-0089(30)346, opposite engineers station 5+417.528; thence S.26°40'38"E. 74.21 feet (22.619 meters) to a point on the southerly right-of-way line of the former South Weber Drive; thence N.89°27'37"W. 2519.66 feet (767.992 meters) parallel with the north line of said section 35 to the Quarter Section line; thence N. 0°23'25" E. 33.00 feet (10.058 meters) along said Quarter Section line to the north Quarter corner of said Section 35; thence N.00°03'29"E. 33.00 feet (10.058 meters) to the point of beginning. The above described tract of land contains 165,177 square feet, or 3.792 acres in area.

- 2. This abandonment will become effective upon approval of the Deputy Director of the Utah Department of Transportation.
- 3. The accompanying letter, memorandums, quit claim deed, exhibits, affidavits, and map will be made part of this abandonment.
