
#### RECOMMENDED LEGISLATIVE CHANGES IN STATE ROAD SYSTEM

ROUTE #62 (1,199)FAS 318

Previous Description: From Plateau Junction on route #24 via
Koosharem to route #22 near Otter Creek
reservoir.

Recommended Description: From Plateau Junction on route #24 via
Koosharem to route #22 near Otter Creek
reservoir, with a spur connection to
Burrville.

Comments: Recommended for Commission action. Approved January 19, 1960 This road was inadvertently transferred to the Sevier County road system in 1950.



# State Route 62

Whereas:

The completion of Projects S-0318(2) and S-0318(3), from junction U-22 near Otter Creek Reservoir to Greenwich for a distance of approximately 20 miles, has resulted in the realignment of SR-62 between engineer's stations 375+- & 595+-, between sta. 600+- & 612+-, between sta. 647+- & 747+-, between sta. 800+- & 830+-, between sta. 1010+- & 1333+-, and between sta. 1335+- & 1339+-, with a decrease of 0.779 mile in the State Route System.

These sections on the old alignment of SR-62 no longer serve any need.


Therefore, it is recommended that they be abandoned and taken off the State System.

Near the junction of U-22 & U-62 there is a by passed section of U-62 located Lt. of sta. 13hh+- to sta. 1365+- that should be placed on the Piute County road system. This section of road runs easterly from station 13hh across the Otter Creek spillway and intersects U-22 approximately 2000 ft. east of Jct. of U-62 & U-22. The length of the section is approximately 0.6 mile.

These changes have been recommended by Mr. W. J. Stephenson, District Engineer, and concurred in by the Piute County Commission.

THEREFORE, BE IT RESOLVED, that State Route 62 be transferred to the new alignment created by the construction of Projects S-0318(2), S-0318(3) between the junction with SR-22 near Otter Creek Reservoir and Greenwich. And be it further resolved that the old alignment of SR-62 between engineer's stations 375+- & 595+-, between sta. 600+- & 612+-, between sta. 647+- & 747+-, between sta. 800+- & 830+-, between sta. 1010+- & 1333+-, and between sta. 1335+- & 1339+-, be abandoned and taken off the State Route System, and that portion between engineer's stations 1344+- to 1365+- be transferred to the jurisdiction of Piute County.

- 2. That by this action the State Route designation of 22 between Kingston Junction and Otter Creek Junction will be redesignated as State Route 62.
- 3. That by this action there will be no change in the State System of Highways mileage.
- 4. That the map exhibit attached illustrating the action taken herewith is hereby incorporated as a part of this submission.



SUBJECT: Request Change of S.R. Route Nos. S.R. 62 and S.R. 22

It has come to our attention there is considerable out of state traffic using State Road 22 through Kingston Canyon and S.R. 62 from Otter Creek Junction north to Jct. with S.R. 24. This route is apparently used as a short cut for California -Colorado traffic.

At present much of the traffic is being confused by the two route numbers. It is our suggestion that the present section of S.R. 22 from M.P.41.87 to M.P. 53.64, or further described as being from Otter Creek Jct. westerly to Jct. with U.S. 89, be redesignated as S.R. 62.

This would simplify directing traffic from U.S. 89 at Kingston Jct. to S.R. 24 at Koosharem Jct. by providing one State Road number instead of two.

Attached is a map showing in red the proposed change.
