WHEREAS, to maintain continuity in the State System of Highways and assist the touring public it has been recommended that present State Route 63 from State Route 24 near Salina northwesterly via Scipio to Route 1 (Interstate Route 15) be redesignated as part of State Route 26.

NOW THEREFORE, be it resolved as follows:

That State Route 26 will be: From State Route 27 in Delta southeasterly via Holden, including roads to the north and south comprising the Holden Couplet, to Route 1 (Interstate Route 15) and commencing again on Route 1 (Interstate Route 15) near Scipio southeasterly via Scipio to a junction with State Route 24 near Salina,

That by this action the designation of State Route 63 will be deleted in its entirety and the 63 designation route markers shall be removed and replaced with 26 designation route markers,

That the map illustrating the action taken herewith be hereby incorporated as a part of this submission.

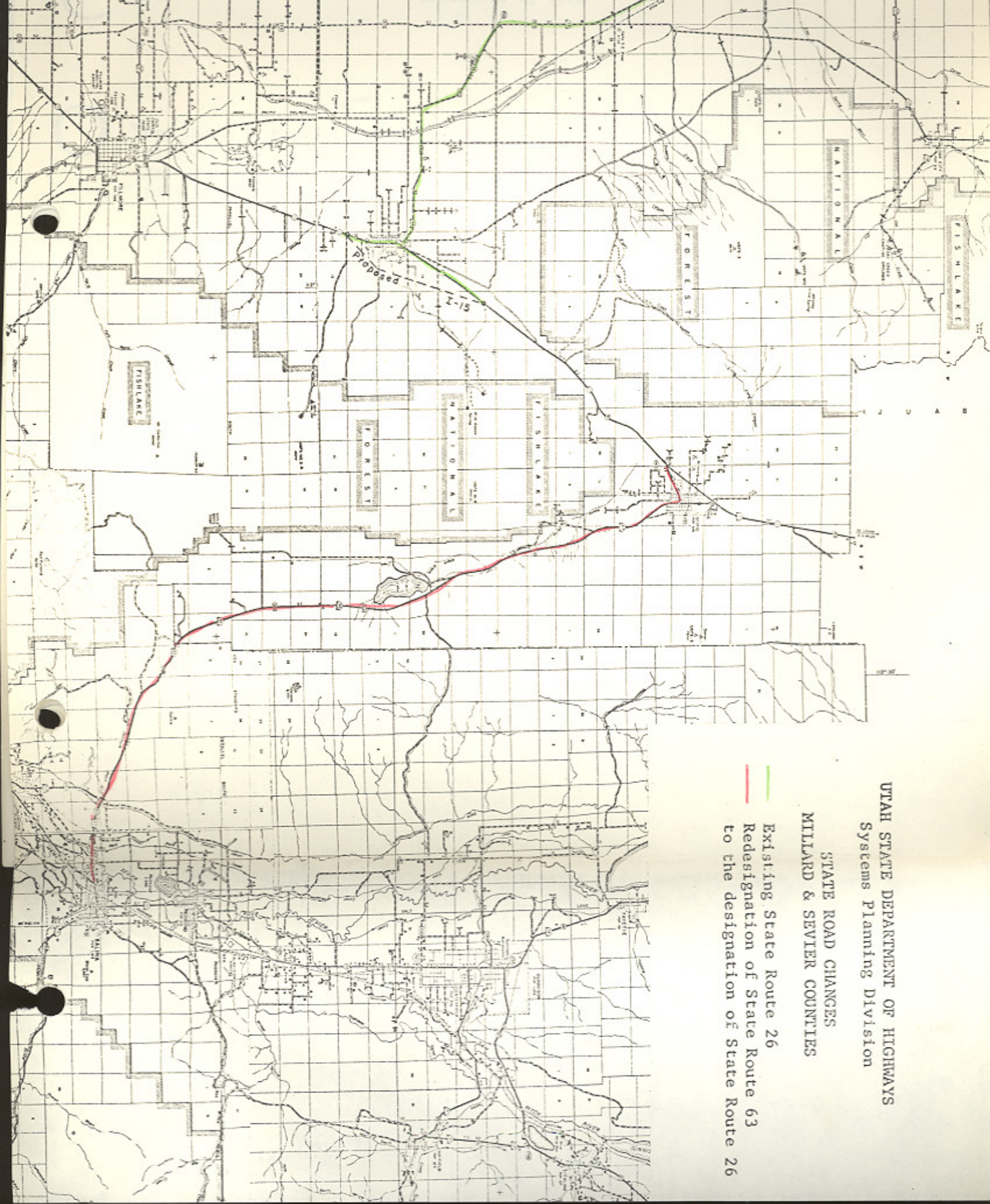

Subject: Redesignation of SR-63 in Millard and Sevier Counties

Effective August 27, 1971, the Utah State Road Commission approved the redesignation of SR-63 from State Route 24 near Salina northwesterly via Scipio to Route 1 (Interstate Route 15) as State Route 26.
