




The portion of the old right of way requested by Lehi City as per your memorandum of October 12, 1971, and E. E. Lovelace s memorandum of October 1, 1971, has been researched. Right of way records indicate that this portion of the right of way belongs to Lehi City and was part of the State's highway in accordance with Utah Code 27-12-86 and 27-12-87. No actual instruments other than Road Commission and legislative action designating the City streets as a State Highway are in our records.



WHEREAS, Section 72-4-102 of the Utah State Code provides for "Additions to or deletions from the state highway system – Designation of Highways as state highways between sessions", and

WHEREAS, the Utah Department of Transportation and Lehi City have agreed to the transfer of maintenance and jurisdictional responsibilities of roadway known as SR-197 and portion of roadway known as SR-73, and

WHEREAS, the Utah Department of Transportation and the City of Saratoga Springs have agreed to the transfer of maintenance and jurisdictional responsibilities of a portion of roadway known as SR-73, and

WHEREAS, the Utah Department of Transportation, Lehi City, and the City of Saratoga Springs has entered into a cooperative agreement's for snow removal and traffic signals, and

WHEREAS, the Region Three Director, along with Systems Planning and Programming and the duly appointed officials of Lehi City and the City of Saratoga Springs, concur with the request to transfer maintenance and jurisdictional responsibilities to Lehi City and the City of Saratoga Springs for the transferred roads described herein.

NOW THEREFORE, be it resolved as follows:

- 1. Roadway known as SR-197 and legally described "From Route 73 northerly on Fifth West Street to Route 89 in Lehi" a distance of 1.083 ± miles, be deleted from the state highway system and transferred to the jurisdiction and maintenance responsibility of Lehi City upon passage of the Utah Transportation Commission, and be added to Lehi City's roadway system as Federal Route 2887 increasing Lehi City's class "C" funding and remain functionally classified as Minor Arterial.
- 2. Roadway known as a portion of SR-73 in Lehi City from the west side of the Jordan River Bridge, Lehi City's west limits to 850 East (Millpond Road) a distance of 4.177 + miles, be deleted from the state highway system and transferred to the jurisdiction and maintenance responsibilities of Lehi City upon passage of the Utah Transportation Commission, and be added to Lehi City's roadway

system as Federal Route 2895 increasing Lehi City's class "C" funding and remain functionally classified as Other Principal Arterial.

- 3. Roadway known as a portion of SR-73 in the City of Saratoga Springs from SR-68 (Redwood Road) to the west side of the Jordan River Bridge, the City of Saratoga Springs East City Limits a distance of 0.571 ± miles, be deleted from the state highway system and transferred to the jurisdiction and maintenance responsibility of the City of Saratoga Springs upon passage of the Utah Transportation Commission, and be added to the City of Saratoga Springs roadway system as Federal Route 2895 increasing the city of Saratoga Springs class "C" funding and remain functionally classified as Other Principal Arterial.
- 4. The Utah Department of Transportation has set aside \$6 million in the State's current fiscal budget for the reconstruction project of SR-73 from US-89 to the Jordan River (Lehi City's western boundary). This money will be transferred to Lehi City for the reconstruction of the road less the dollars needed for the resurfacing of SR-73 from 850 East (Millpond Road) to US-89 which is estimated at \$271,158. Therefore, as of the date of the jurisdictional transfer Lehi City shall receive \$5,728,842 to complete the remaining of the scheduled project. If the estimated \$271,158 resurfacing project cost is completed under budget Lehi City will be reimbursed the surplus remaining. Also in the event that this resurfacing project cost is completed over budget, Lehi City will pay the over budget amount using these transferred dollars. It is also understood that the reconstruction dollars will be used to complete roadway improvements, including, but not limited to the following: replacement of curb, gutter, and sidewalk along various sections; mitigating drainage issues associated with the road; rehabilitation of various "problem areas" and resurfacing the entire roadway corridor as described above.
- 5. The Utah Department of Transportation has agreed to transfer a one-time sum of \$26,501 to Lehi City for SR-197. This is equal to the equivalent of one (1) year of maintenance and pavement preservation budget. These funds will be forwarded at the time of jurisdictional transfer.
- 6. The Utah Department of Transportation has agreed to transfer a one-time sum of \$27,700 to the City of Saratoga Springs for SR-73. This is equal to the equivalent of one (1) year of maintenance and pavement preservation budget. These funds will be forwarded at the time of jurisdictional transfer.

- 7. The Utah Department of Transportation, Lehi City, and the City of Saratoga Springs have entered into cooperative agreements where it is written to set the terms and conditions for snow removal and traffic signals under which the jurisdictional transfer shall be performed.
- 8. The accompanying letter of intent from Lehi City, letter of agreement from the City of Saratoga Springs, cooperative agreement's, and map marked Exhibit "A" will be made part of this resolution.

Dear Shane:

I am writing to follow up on conversations we have been having regarding the jurisdictional transfer of State Road (SR) 73 (Lehi Main Street) and SR 197 (500 West) from the Utah Department of Transportation (UDOT) to Lehi City. I appreciate your willingness to work with the city in striving to find a "win-win" solution for both parties. Based on our discussions, I would like to summarize, in the form of this Letter of Intent, to transfer the roads pending approval from the Lehi City Council and the Utah State Transportation Commission. Here is a summary of agreed upon issues:

1. Transfer of Project Dollars. As you have represented, UDOT has set aside \$6 million in the state's current fiscal budget for the reconstruction of SR 73 from U.S. 89 (State Street) to the Jordan River (Lehi City's western boundary along SR 73). It is the intent of both parties to transfer the designated \$6 million from the State of Utah to Lehi City for the reconstruction of the road, less the dollars needed for UDOT to resurface the roadway from 850 East (Millpond Road) to U.S. 89 (State Street). Per UDOT estimates, the monies needed to complete this section of the project are \$271,158. Therefore, as of the date of jurisdictional transfer, UDOT will forward to Lehi City \$5,728,842 to complete the remaining portion of the scheduled project. Moreover, UDOT also agrees to reimburse Lehi City for the difference between the estimated \$271,158 project cost and actual project costs in the event the work is completed under budget and a surplus remains.

In addition, it is understood by both parties that the noted reconstruction dollars will be used to complete roadway improvements, including, but not limited to the following: replacement of curb, gutter, and sidewalk along various sections; mitigating drainage issues associated with the road; rehabilitation of various "problem areas" and resurfacing the entire roadway corridor as described above.

- 2. Traffic Signals. UDOT agrees to assume perpetual responsibility for the traffic signal at SR 73 and 850 East (Millpond Road) and a future signal at SR 197 (500 West) and U.S. 89 (State Street) at the time of transfer. In addition, UDOT also agrees to pay the full cost of maintenance and operations for three (3) additional signals along SR 73 (Lehi Main Street) for the next four (4) years, terminating December 31, 2015. These specific traffic signals are located at the following intersections: (1) SR 73 (Lehi Main Street) and 500 East (Pioneer Drive), (2) SR 73 (Lehi Main Street) and Center Street, and (3) SR 73 (Lehi Main Street) and 2300 West. Moreover, in the event that Lehi City was to add additional signals along SR 73 (Lehi Main Street) from 850 East (Millpond Road) to the Jordan River, UDOT also agrees to maintain those new signals for the next four (4) years, terminating December 15, 2015.
- 3. **Snow Removal.** UDOT agrees to assume snow removal responsibility for Lehi City's section of SR 73 (Lehi Main Street) from 850 East (Millpond Road) to the Jordan River (Lehi City's western boundary along SR 73), consistent with snow removal criteria set by UDOT, for the 2011-2012 winter season.
- 4. Consideration for SR 197 (500 West). In addition to the noted dollars associated with SR 73 (Lehi Main Street), UDOT agrees to transfer to Lehi City a one-time sum of \$26,501 equal to the equivalent of one (1) year of UDOT's maintenance and pavement preservation budget for SR 197 (500 West). The noted funds will be forwarded to the city at the time of jurisdictional transfer.

Based on meeting the aforementioned criteria, Lehi City agrees to assume responsibility for jurisdiction and maintenance of the following (except for signal maintenance and snow removal for the years specified above): (1) SR 73 (Lehi Main Street) from 850 East (Millpond Road) to the Jordan River (Lehi City's western boundary along SR 73), and (2) SR 197 (500 West) from SR 73 (Lehi Main Street) to U.S. 89 (State Street). Furthermore, it is understood that UDOT will continue to operate and maintain, in perpetuity, SR 73 (Lehi Main Street) from 850 East (Millpond Road) to U.S. 89 (State Street).

THIS COOPERATIVE AGREEMENT, made and entered into this _____ day of ______, 2011 by and between the UTAH DEPARTMENT OF TRANSPORTATION, hereinafter referred to as "UDOT," and LEHI CITY, a municipal corporation of the State of Utah created, hereinafter referred to as the "CITY",

RECITALS

WHEREAS, UDOT desires to transfer ownership and full jurisdiction of SR-197 (500 West) in Lehi to the CITY; and

WHEREAS, UDOT desires to transfer ownership and full jurisdiction of SR-73 (Main Street) in Lehi to the CITY, beginning at the West side of 850 East, ending at the Westerly city limit, (West side of the Jordan River); and

THIS COOPERATIVE AGREEMENT is written to set out the terms and conditions under which the jurisdictional transfer shall be performed.

NOW, THEREFORE, it is agreed by and between the parties hereto as follows:

1. UDOT agrees to release payment in the form of a ONE TIME LUMP SUM AMOUNT OF \$5,728,842.00 to the CITY to be used for the reconstruction of SR-73. Per UDOT estimates, the cost to resurface that section of SR-73 identified as 850 East to US-89 is approximately \$271,158.00. UDOT also agrees to reimburse the CITY for the difference between the estimated \$271,158.00 project costs and actual project costs in the event the work is completed under budget and a surplus remains. Adversely, if the actual resurfacing costs over-run the estimated \$271,158.00, CITY shall reimburse UDOT the cost of said over-run.

In addition to the noted dollars associated with SR-73 (Lehi Main Street), **UDOT** agrees to transfer to the **CITY** a **ONE TIME LUMP SUM AMOUNT OF \$26,501.00**, equal to the equivalent of one (1) year of **UDOT's** maintenance and pavement preservation budget for SR-197 (500 West). The noted funds will be forwarded to the **CITY** at the time of jurisdictional transfer.

TOTAL ESTIMATED COST TO UDOT \$5,755,343.00

2. **UDOT** further agrees to provide snow removal for both SR-73 and SR-197 through the winter season of 2011-2012. All snow removal services will cease upon the end of season 2012.

Beginning 2012-2013, all snow removal services for both routes will become the sole responsibility of the CITY. All other operations and maintenance responsibilities, services, needs and costs become the sole responsibility of the CITY effective upon the execution of the jurisdictional transfer. CITY agrees to assume ownership and all maintenance responsibilities associated with the above noted routes and to relieve UDOT from any and all maintenance responsibilities and liability associated with said maintenance. CITY acknowledges that the roadway structure over the Jordan River will now be within the CITY's jurisdiction. All maintenance and operation responsibilities of said structure become the sole responsibility of the CITY. CITY further relieves UDOT of any responsibility and liability associated with said roadway structure.

3. UDOT further agrees to continue to maintain in perpetuity the existing traffic signals located at 850 East & SR-73 (Lehi Main Street) and SR-197 (500 West) & US-89 in Lehi. UDOT further agrees to continue to maintain the following traffic signals in Lehi; 500 East & SR-73 (Lehi Main Street), Center Street & SR-73 (Lehi Main Street) and 2300 West & SR-73 (Lehi Main Street) through December 15, 2015. In the event that Lehi City constructs additional signals along SR-73 (Lehi Main Street) from 850 East (Millpond Road) to the Jordan River, UDOT further agrees to maintain those new signals, excluding the payment for power usage of said new signals and street lighting associated with said new signals, for the next four (4) years, terminating December 15, 2015. CITY further agrees to assume ownership and all maintenance responsibilities associated with the above noted traffic signals and any additional traffic signals the CITY constructs along this corridor beginning December 16, 2015. The street lighting at these locations will continue to be owned and maintained by the CITY as those responsibilities are currently defined.




- 2. UDOT further agrees to provide snow removal for SR-73 through the winter season of 2011-2012. All snow removal services will cease upon the end of season 2012. Beginning 2012-2013, all snow removal services for SR-73 will become the sole responsibility of the CTTY. All other operations and maintenance responsibilities, services, needs and costs become the sole responsibility of the CTTY effective upon the execution of the jurisdictional transfer. CTTY agrees to assume ownership and all maintenance responsibilities associated with the above noted route and to relieve UDOT from any and all maintenance responsibilities and liability associated with said maintenance.
- 3. UDOT further agrees to continue to maintain the traffic signal located at the intersection of SR-73 and SR-68. UDOT further agrees to maintain the existing traffic signal located at SR-73 and East Commerce Drive until Dec. 15, 2015. The street lighting at this location will continue to be owned and maintained by the CITY as those responsibilities are currently defined.

Resolution

<u>Transfer Portion of SR-73 to the City of Saratoga Springs</u> <u>Utah County</u>

WHEREAS, Utah Code Section 72-4-102 describes the process for the deletion of highways from the state highway system; and,

WHEREAS, the completion of a newly constructed portion of highway (Project No. S-0145 (7)0) provides an extension to SR-145 also known as Pioneer Crossing from SR-68 (Redwood Road) to SR-73 in the City of Saratoga Springs, and will be maintained and operated by the Utah Department of Transportation (UDOT); and,

WHEREAS, a new road segment was also constructed with the Pioneer Crossing Extension Project and involved the realignment of a portion of SR-73 from the Pioneer Crossing Extension to the existing alignment of SR-73 to provide a continuous roadway from SR-145 (Pioneer Crossing) to SR-68 (Redwood Road) and,

WHEREAS, a portion of the old alignment of SR-73 from the new road segment to almost 800 West will end in a cul-de-sac and,

WHEREAS, UDOT desires to transfer ownership and full jurisdiction of a portion of SR-73 and a new road segment that was built as part of the Pioneer Crossing Extension Project, and the old alignment portion of SR-73 that has been turned into a culde-sac to The City of Saratoga Springs and,

WHEREAS, UDOT and the City of Saratoga Springs have entered into a cooperative agreement to define the terms and conditions under which the jurisdictional transfer shall be performed and,

WHEREAS, the UDOT Region Three Director, along with the appropriate staff of the Program Development Division and the duly appointed officials of The City of Saratoga Springs, concur with the request to transfer ownership maintenance and jurisdictional responsibilities for the transferred road described herein.

NOW THEREFORE, be it resolved as follows:

A new road segment was constructed to connect SR-145 (Pioneer Crossing) to
the remaining portion of SR-73, and the remaining portion of roadway of SR73 from the new road segment to SR-68 (Redwood Road) a distance of 0.871

± miles will be deleted from the State Highway System and transferred to the
full ownership and jurisdiction to the City of Saratoga Springs and will be
known as Crossroads Blvd as shown in Exhibit "A".

Transfer Portion of SR-73 to the City of Saratoga Springs Utah County

- a. For the aforementioned transferred roadway will remain functionally classified as Other Principal Arterial and will be placed on the Federal Aid Route System as a portion of Route 2895 adding 0.871 ± miles to the City of Saratoga Springs road mileage.
- 2. A portion of roadway that was part of the old alignment of SR-73 and has a new connection extending from Crossroads Blvd to approximately 800 West ending in a cul-de-sac a distance of 0.354 ± miles will be deleted from the State Highway System and transferred to the full ownership and jurisdiction to the City of Saratoga Springs and will be known as 1400 North as shown in Exhibit "A".
 - a. The aforementioned roadway will be classified as Local Road adding 0.354 ± miles to Saratoga Springs road mileage.
- 3. The aforementioned roadways will reduce the State Highway System's road mileage by 1.225 ± miles and SR-73 will be described as follows: From Route 36 northeast of St. John Station southeasterly on Five Mile Pass to Route 145; then easterly again beginning at 850 East in Lehi to Route 89.
- 4. By these actions, UDOT and the City of Saratoga Springs have entered into a Cooperative Agreement to define the terms and conditions of the aforementioned transferred roadways. In the Cooperative Agreement, UDOT agreed to transfer fee title of the described roadways to Saratoga Springs by quitclaim deed.
- 5. These actions will become effective upon passage of this resolution by the Utah Transportation Commission.
- 6. The accompanying letter of agreement from the City of Saratoga Springs and Cooperative Agreement between the City of Saratoga Springs and UDOT, and map marked Exhibit "A" will be made part of this resolution.



Description:

A. Topic:

This item is for the approval of a cooperative agreement with UDOT for the transfer of a portion of SR-73 west of Redwood Road (SR-68) and of a new road segment that was constructed with the Pioneer Crossing Extension Project from Pioneer Crossing to SR-73 to Saratoga Springs. These roadways will be known as Crossroads Blvd. (extending from Redwood Road to Pioneer Crossing) and 1400 North (extending from Crossroads Blvd to almost 800 West and ending in a cul-de-sac).

B. Background:

The Pioneer Crossing Extension project involved the relocation of SR-73 to provide a continuous connection between Pioneer Crossing and that portion of SR-73 west of the City Boundary to provide a more efficient movement of east-west traffic through the City.

With the Completion of this project the remnant portion of SR-73 (east of Pioneer Crossing Ext to Redwood Road) is no longer a regional corridor and UDOT is proposing to transfer the property and Right-of-Way to the City. There is also a new road segment that was constructed to connect the Pioneer Crossing Extension to the remaining portion of SR-73 that is also being proposed for transfer to the City so that the City will own and operate a continuous roadway (Crossroads Boulevard) from the Jordan River to Pioneer Crossing.

Staff has negotiated with UDOT for sufficient pavement preservation funds to bring these portions of roadways up to an acceptable standard as a condition of acceptance.

Analysis:

This transfer is consistent with previous transfers in which those portions of SR-73 east of the Jordan River were transferred to Lehi and Saratoga Springs with the completion of the first phase of Pioneer Crossing. With the completion of the Pioneer Crossing Extension project, this transfer will complete the process as was anticipated when UDOT begin the Pioneer Crossing Extension Project.

C. Recommendation:

I recommend that the City Council approve the Cooperative Agreement with UDOT for the transfer of ownership and full jurisdiction of that portion of Crossroads Boulevard west of Redwood Road (SR-68) and 1400 North.

COOPERATIVE AGREEMENT

RECITALS

WHEREAS, UDOT desires to transfer ownership and full jurisdiction of a portion of SR-73 and a new road segment constructed with the Pioneer Crossing Extension Project PIN11349 in Saratoga Springs to the CITY; and

WHEREAS, the portion of SR-73 to be transferred begins at the western terminus (end of cul-de sac) of the amended roadway (approximate engineers station 200+31.21 on Sheet RD-14) and extends easterly to the intersection of SR-73 and SR-68, the current western limit of the CITY's jurisdiction of Crossroad Blvd, (as more specifically identified in the jurisdictional transfer that was executed November 30th, 2011, agreement number 128514); as shown in "Exhibit A", attached hereto and thereby made a part hereof; and

WHEREAS, UDOT desires to transfer ownership and full jurisdiction of the new segment of Crossroads Blvd. that extends from Pioneer Crossing (SR-145 approximate engineers station 401+00 on Sheet RD-12) northeasterly to SR-73 (approximate engineers station 419+30 on Sheet RD-13); and

WHEREAS, that portion of SR-73 west of SR-68 and the new road segment from station 401+00 to 419+30 as shown on sheets RD-12 and RD-13 will be renamed Crossroads Boulevard and will extend from Redwood Road (SR-68) westerly to Pioneer Crossing; and

WHEREAS, the portion of SR-73 west of the new Crossroads Boulevard (beginning at engineer's approximate engineer's station 219+00 on Sheet RD-13 and extending westerly to the terminus (end of cul-de sac) of the amended roadway (approximate engineers station 200+31.21 on Sheet RD-14) will be renamed 1400 North; and

WHEREAS, the new Crossroads Boulevard and 1400 North roadways are collectively known as the "Roadways" for the purposes of this agreement and are more clearly defined in "Exhibit B", attached hereto and thereby made a part hereof; and

WHEREAS, CITY desires to accept ownership and full jurisdiction from UDOT the "Roadways" with certain terms and conditions; and

THIS COOPERATIVE AGREEMENT is written to set out the terms and conditions under which the jurisdictional transfer shall be performed.

NOW, THEREFORE, it is agreed by and between the parties hereto as follows:

1. UDOT agrees to provide fee title, free from monetary encumbrances, liens, or assessments to the CITY of the Roadways through a quit claim deed or other instrument acceptable to the CITY. Such

deed(s) shall be recorded within 30 days of the date of this agreement with a copy of the recorded documents provided to the CITY.

- 2. The CITY agrees to assume full responsibility regarding the operation and maintenance of the roadways immediately upon transfer of title as recorded at the Utah County Recorder's office.
- The CITY hereby agrees to own and become solely responsible for all operation and maintenance
 responsibilities inclusive of all needs and costs of the Roadways at no additional cost to UDOT
 including all snow removal services.
- 4. UDOT further agrees to continue to maintain the traffic signal located at the intersection of Crossroads Blvd (formerly SR-73) and SR-68 and to accept and assume all maintenance and liability obligations. All street lighting along the Roadways are to be owned and maintained by the CITY as those responsibilities are currently defined.
- 5. UDOT will perform the following tasks and maintenance items within 90 days of the execution of this agreement.
 - a. Install the reflective tape on the backs of the signal heads at the signal at Crossroads Boulevard and the west segment of Commerce Drive before the transfer.
 - b. Deliver to the CITY as-built plans for the Roadways as well as for the signal at Crossroads Boulevard and the west segment of Commerce Drive.
 - c. Replace all street signs at applicable locations on or adjacent to the Roadways from SR-73 to Crossroads Blvd.
- 6. UDOT further agrees to release payment to the CITY, contingent on the approval of this Jurisdictional Transfer by the Utah Transportation Commission, in the form of a ONE TIME LUMP SUM PAYMENT in the amount of ONE HUNDRED SEVENTY FIVE THOUSAND DOLLARS (\$175,000.00) to be used for pavement preservation on that portion of SR-73 covered by this Jurisdictional Transfer Cooperative Agreement. This payment shall be delivered to the City by check or wire transfer upon the approval of this Jurisdictional Transfer by the Utah Transportation Commission. In the event the Utah Transportation Commission does not approve the Lump Sum Payment, this Agreement becomes null and void unless otherwise agreed to in writing by the parties.

TOTAL COST TO UDOT = \$175,000.00


