RECOMMENDED CHANGE IN STATE ROUTE SYSTEM

State Route 77

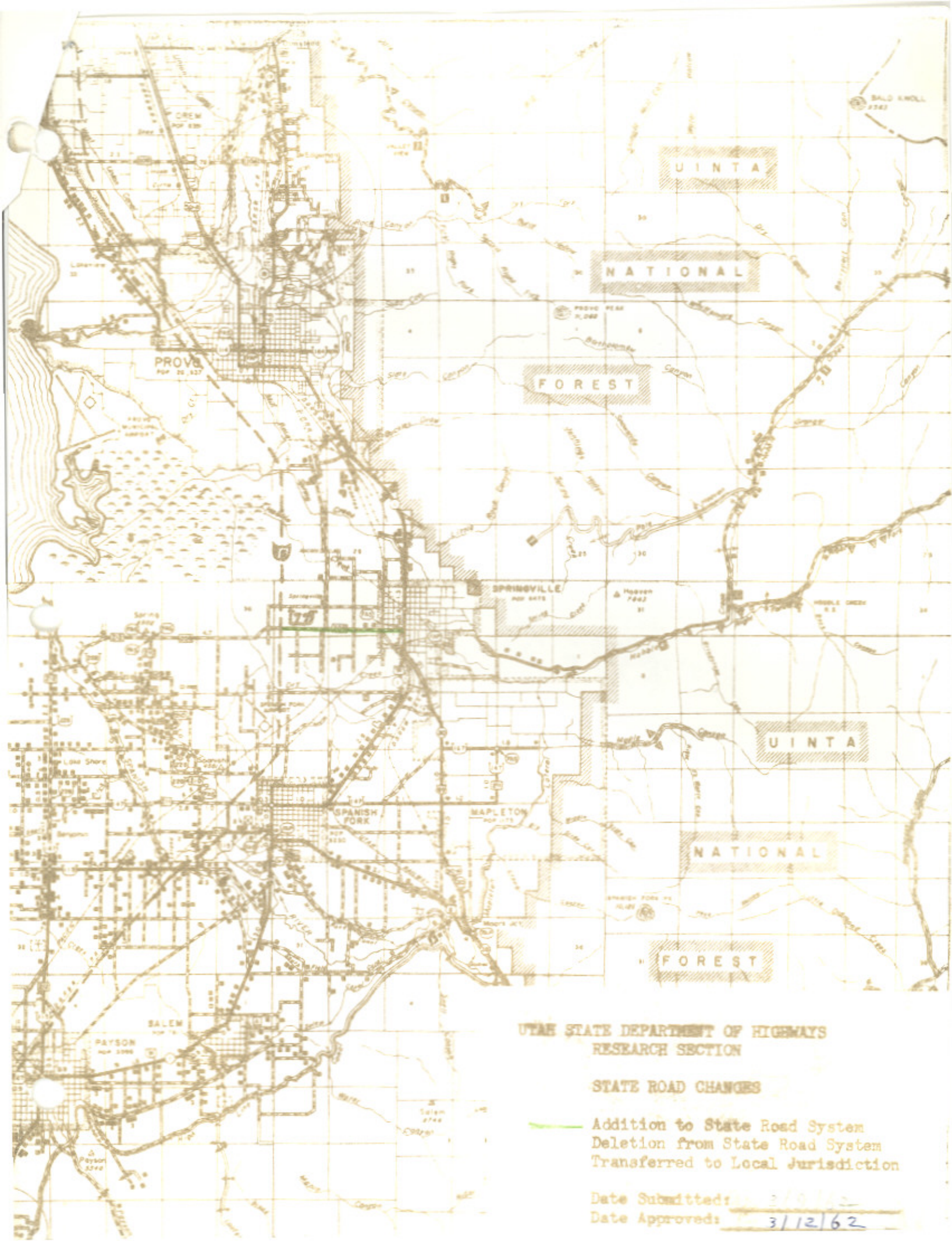
Whereas:

To provide an adequate connection to Interstate Route 15 in the vicinity of Springville, it is recommended that Fourth South Street in Springville between Interstate Route 15 and UI-US 91 be added to the State Route System as an interim designation. At the present time this section of roadway is on the Local Federal-aid Secondary System, and upon approval of this recommendation, will become a part of the State Federal-aid Secondary System. The addition of this route would increase the State Route mileage approximately 2.2 miles.

THEREFORE, BE IT RESOLVED that State Route 77 be added as an interim designation, subject to the approval of the legislature; the description of this route being: from Interstate Route 15 easterly, via Fourth South Street to Main Street in Springville.
