Logan via Hyrum to Wellsville May 12, 1931

WHEREAS, a roadway has been constructed to the new Visitors Center and Parking Area at Hardware Ranch, and

WHEREAS, Mr. Bert Taylor, District Engineer, recommends that this section of roadway be included in the State System of Highways, and

WHEREAS, approximately 0.2 + - mile of the roadway is presently on the Collector Road System, the Cache County Commission and Mr. E. Paul Gilgen, Local Government Projects Engineer, concur in the deletion of this portion of roadway from the Collector Road System.

NOW THEREFORE, be it resolved as follows:

That the roadway to the Visitors Center and Parking Area at Hardware Ranch be designated as part of State Route 101,

That by this action the termini of Collector Road 311 will be relocated approximately 0.2 mile south of its present termini with State Route 101 near Hardware Ranch,

That the memorandum from Bert Taylor, and the letter from the Cache County Commission relating to the aforementioned revisions of Collector Road 311 and State Route 101 be hereby incorporated as a part of this submission,

That by this action State Highway System mileage will increase 0.8 + - mile and Collector Road System mileage will decrease 0.2 + - mile,

That the map attached illustrating the action taken herewith be hereby incorporated as a part of this submission.
