## **DESCRIPTION OF RESOLUTION CHANGE**

(A). - New constructed Portion of roadway in Tooele City on 1000 North from SR-112 to SR-36 becomes new portion of SR-112. Old Portion of SR-112 from 1000 North to SR-36 transferred to Tooele City.

## **Resolution**

## <u>Transfer Portion of SR-112 to Local Jurisdiction</u> <u>Relocation of Portion of SR-112</u> <u>Tooele County</u>

WHEREAS, Section 72-4-102 and 72-4-103 of the Utah Code Annotated 1953, as amended, authorize the Transportation Commission to approve additions to or deletions from the state highway system, along with the return to county or municipality or abandonment between general sessions of the State Legislature and,

**WHEREAS,** construction of a new highway (Project F – LC45 (8)) which will provide an alternate route on 1000 North from SR-112 to 600 West in Tooele City, and connects to new construction of highway (Project STP-2684(4)0) on 1000 North from 600 West to SR-36 (Main Street) in Tooele City and,

WHEREAS, the new construction of highway (Project F - LC45 (8)) on 1000 North, between SR-112 and 600 West, will use money from the American Recovery and Reinvestment Act (ARRA) and,

WHEREAS, the new construction of roadway on 1000 North, from SR-112 easterly to SR-36 has been requested by the Region Two Director to be added to the State System of Highways as a portion of SR-112 and transferring an existing portion of SR-112 to Local Jurisdiction and,

WHEREAS, the duly appointed officials of Tooele City entered into agreement dated April 7 2009, with the Utah Department of Transportation (UDOT) stipulating concurrence as to the transfer of portion of SR-112 and,

WHEREAS, the appropriate staff of the Systems Planning and Programming Division having reviewed all stipulations defined within this resolution, concurs with UDOT's Region Two Director, for the justification of all recommendations defined herein.

NOW THEREFORE, be it resolved as follows:

 The new construction of roadway, Project F – LC45 (8) and Project STP-2684(4)0, from SR-112 traversing on 1000 North to SR-36 (Main Street) for 3.01± miles be added to the State System of Highways, including the existing railroad underpass structure as a portion of SR-112. The Functional Classification of this new segment will be Urban Other Principal Arterial. The roadway classification will permit reasonable private property access to be established at a later time through a corridor preservation agreement, and is anticipated to accommodate commercial development. <u>Resolution</u> <u>Transfer Portion of SR-112 to Local Jurisdiction</u> <u>Relocation of Portion of SR-112</u> <u>Tooele County</u>

- 2. The portion of SR-112 from Milepost 5.874 to 8.603, totaling 2.729± miles will be removed from the State Highway System and included in Tooele City's roadway system as a portion of Federal Route 2665 and will be functionally classified as Urban Minor Arterial.
- Newly constructed roadway, Project F LC45 (8) 1000 North, between SR-112 and 600 West, Tooele City will obtain all right of way and contribute a maximum of 2,073,000 plus a maximum of 1,000,000 ARRA funds, and The Utah Department of Transportation will contribute the balance of project costs.
- **4.** All transactions described herein will become effective upon completion of all projects, all roadway and streets being open to traffic, and passage by the Utah Transportation Commission.
- 5. The accompanying map (Exhibit "A") and agreements be made part of this resolution.


