RESOLUTION

Deletion of Portion of State Route 127

Whereas, Sections 27-12-27 and 27-12-28 of the Utah Code 1990 provide for the addition or deletion of highways from the State System, along with deletion of highway from State Highway System -return to County, City or Town or Abandonment, and

Whereas, pursuant to House Bill 1, passed in special session of the Utah Legislature on April 18, 1991, appropriating funding to the State Parks and Recreation Department for reconstruction of the causeway roadway, and

Whereas, the District One Director has assessed the afore-mentioned legislation, and concurs with the necessity for deleting the foregoing portion of SR-127 from the State System of Highways, and

Whereas, the Davis County Commission has expressed its willingness to accept the Antelope causeway on their system of highways, and

Whereas, the appropriate staff of the Transportation Planning Division pursuant to the provisions regarding the afore-mentioned legislation, concur with the provision of deleting the foregoing portion of SR-127 from the State System of Highways.

NOW THEREFORE, be it resolved as follows:

1. A portion of SR-127, from its beginning termini, Great Salt Lake State Park Boundary, traversing northeasterly and easterly to the junction of SR-110, a distance of 7.19+ miles be deleted from the State System of Highways and placed under the jurisdiction of Davis County. The remaining portion of SR-127 will retain its present mileposting in order to preserve milepost integrity throughout the State System.
2. The afore-mentioned portion of SR-127 will remain major collector, with its Federal-aid Secondary designation becoming Local FAS-112.
3. This deletion will become actuated upon approval from the Transportation Commission and the Federal Highway Administration.
4. The accompanying letter and map made part of this resolution.

As you are probably aware, Davis County has been interested in the restoration of the causeway to Antelope Island for a number of years.


It appears that this past legislature has appropriated to the Parks Department, bonding proceeds of approximately \$3,000,000 of which could be transferred to Davis County for use in restoration of the causeway.

We are hopeful that with this amount and with some additional appropriation in the future bringing the figure to the estimated \$5,000,000 for the completion, that access to the Island and State Park can soon become a reality.

In anticipation of the need for continued maintenance on such a road as the causeway, Davis County would like to charge a toll for such a purpose and would therefore request of your Department, the transfer of the jurisdiction of this road to Davis County.

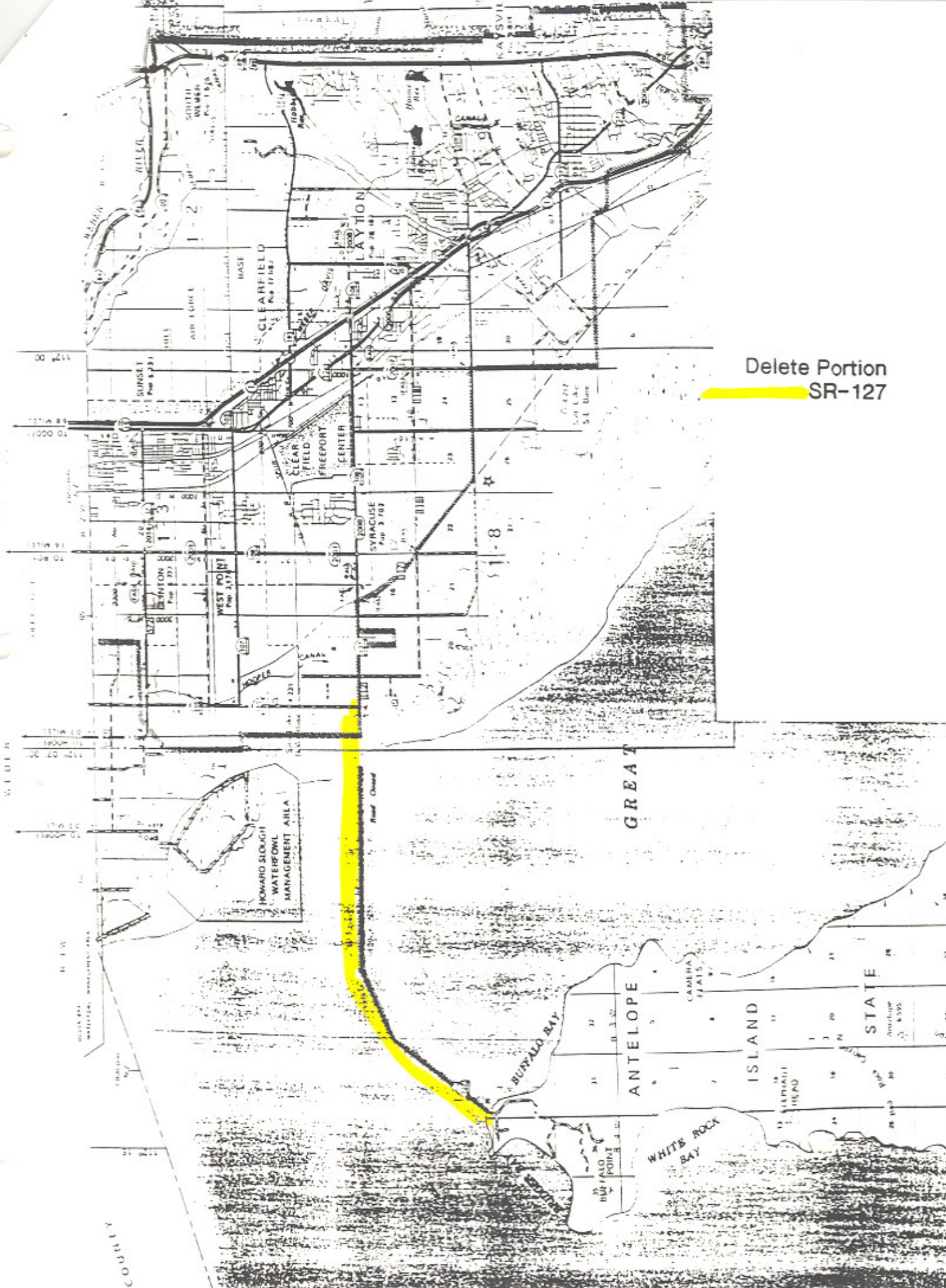
