R E S O L U T I O N Relinquishment of Old Alignment of SR-128 Including Old Dewey Bridge to Grand County Relocation

WHEREAS, Section 27-12-27 of the Utah Code 1987-1988 provides for the addition or deletion of highways from the state highway system and,

WHEREAS, the Grand County Commission has passed a resolution requesting the Utah Department of Transportation to deed the Old Dewey Bridge to Grand County since it has been nominated for inclusion on the National Register of Historic Places and,

WHEREAS, the District Four Director concurs with aforementioned transfer of the Old Dewey Bridge along with the old roadway that resided as State Route 128 and,

WHEREAS, the appropriate staff of the Transportation Planning Division has reviewed the resolution passed by the Grand County Commission and agrees with the jurisdictional transfer of Old Dewey Bridge to Grand County.

NOW THEREFORE, be it resolved as follows:

- 1. The alignment of Old State Route 128 from an intersection on new alignment of State Route 128 approximately 76' south of the new Dewey Bridge traversing easterly, thence northeasterly to where the right of way line on new SR-128 intersects with Old SR-128, (including old Dewey Bridge) a distance of .34+ miles be transferred to the jurisdiction of Grand County.
- 2. The portion of roadway traversing easterly from the intersection on new alignment of State Route 128 approximately 76' south of the new Dewey Bridge to where the old alignment of SR-128 traverses old Dewey Bridge will be Functionally Classified Local, a distance of .13+ miles and will increase Grand County's "B" system mileage by the aforementioned increment.
- 3. The remainder of roadway that is the old alignment of SR-128 transferred to the jurisdiction of Grand County will not be Functionally Classified due to the old Dewey Bridge lacking the structural strength to support vehicle traffic, also the absence of an access on the east side of old Dewey Bridge to the new alignment of SR-128.
- 4. The accompanying letter, Grand County resolution and map be made part of this resolution.

With the completion of the construction of a new bridge across the Colorado River near Dewey, the old Dewey Bridge is no longer being used.

The environmental document for this project stated that "Although the Dewey Bridge no longer has the structural strength to safely facilitate vehicular traffic, it is to be preserved as a historically significant edifice." The document further indicated that "Title to the existing Dewey Bridge is to be transferred from U.D.O.T. to Grand County." A copy of a resolution by the Grand County Commission requesting that U.D.O.T. transfer the existing bridge to them is attached.

Would you please prepare a resolution for the U.D.O.T. Commission to relinquish the section of old SR-128 which the Dewey Bridge occupies to Grand County.
