(A). Addition - From SR-21 near Garrison northerly to SR-50.

R E S O L U T I O N

Garrison Northerly
Addition SR-159, Modification CR-3

WHEREAS, the District 5 Director recommends placing the road north of Garrison from SR-21 to SR-50 on the State Administered Highway System, and

WHEREAS, the Millard County Commission has agreed to improve the road to acceptable standard for placement on the State Administered System, and

WHEREAS, the staff of the Statewide Planning Section has functionally classified this road as a Minor Collector.

NOW THEREFORE, be it resolved that the portion of CR-3 north of Garrison from SR-21 to SR-50, a distance of 8.00 miles, be deleted from the Collector Road System and placed on the State Administered Highway System as SR-159, and

Be it resolved that the State System will increase 8.00 miles, the Millard County's "B" System will decrease 8.00 miles, and the Collector Road System mileage will decrease 8.00 miles to 2567.7 miles, and

Be it further resolved that this action be effective upon the recommendation of the District 5 Director as to when the road has been improved to acceptable standards and upon approval of the State Legislature, and

That the accompanying map be submitted as a part of this resolution.
