1953, AS AMENDED it is hereby resolved as follows:

- That 5300 South in Salt Lake County between State Route 68 (Redwood Road) and State Route 271 (State Street) be designated as State Route 173, a distance of 2.7 + - miles.
- 2. That by this action State Route mileage will increase 2.7 + miles, Murray City "C" mileage will decrease 1.9 + miles, and Salt Lake County "B" mileage will decrease 0.8 + mile.
- 3. That Exhibit "A" attached herewith illustrating the action taken herewith is hereby incorporated as part of this submission.
