RESOLUTION

Addition of State Highway SR-196 Tooele County

WHEREAS, section 27-12-27 of the Utah Code 1997, provides for additions to or deletions from state highway system--Designation of highways as state highways between sessions., and

WHEREAS, it has been determined by duly elected and appointed officials of the State of Utah, The Utah Department of Transportation and The Utah Transportation Commission, that it would be in the best interest of the citizens of the State of Utah, that The Utah Department of Transportation assumes operational control and maintenance of a portion of current Federal Route, number 2652 known as the Skull Valley Road, and

WHEREAS, this action will ensure the citizens of Utah safety compliance with State statutes regulating operation and maintenance of the Skull Valley Road and adjacent roadway accessing prescribed roadway stated herein, and

WHEREAS, The Region Two Director, along with the appropriate staff of the Program Development Division, reviewing the safety concerns related to the operation and maintenance of the prescribed and adjacent roadway concur with the duly elected and appointed officials of the State of Utah and along with the Utah Transportation Commission that the Skull Valley Road should be incorporated as part of the State System of Highways.

NOW THEREFORE, be it resolved as follows:

1. Roadway traversing northerly from a junction with SR-199 near the control gate at Dugway Proving Grounds to the west bound on and off ramps of SR-80 (I-80) at Rowley Junction Interchange a distance of 36.78±, known as the Skull Valley Road a portion of Federal Route 2652, be place on the State System of Highways and assigned route number SR-196.

2. The defined roadway will remain functionally classified Major Collector.

3. This addition will become effective upon approval of the Utah Transportation Commission.
