DESCRIPTION OF RESOLUTION CHANGE

(A). Added as a State Route -

Main Street in Fairview from US-89 to SR-31

RESOLUTION

Addition of State Route 231 in Fairview, Utah

WHEREAS, under Utah State Transportation Code 74-3-102 (4) The Department has jurisdiction and control over all state highways; and

WHEREAS Utah Code 72-4-102 provides for additions and deletions from the State Highway System between Legislative Sessions; and

WHEREAS the roadway known locally as “D” Street between 7th North Street and 8th North Street, Fairview Utah, was included as part of State Route 32/U.S. Highway 89 between 1912 and 1937, until SR-32/US-89 were re-routed westward to Hill Top; and

WHEREAS “D” Street between 7th North Street and 8th North Street was then re-designated as part SR-91 in 1937; and

WHEREAS in 1969 the State Legislature withdrew SR-91 from the State Highway System; and

WHEREAS, it has become desirable for safety, circulation, maintenance, and signage reasons that “D” Street be reincorporated into the State Highway System and serve as a direct connection between existing highway US-89 at the intersection of said “D” Street and 7th North Street, and existing highway SR-31 at the intersection of said “D” Street and 8th North Street in Fairview;

THEREFORE be it resolved that “D” Street in Fairview, UT, between 7th North Street and 8th North Street, be added to the Utah State Highway System and be designated as Utah State Highway 231.

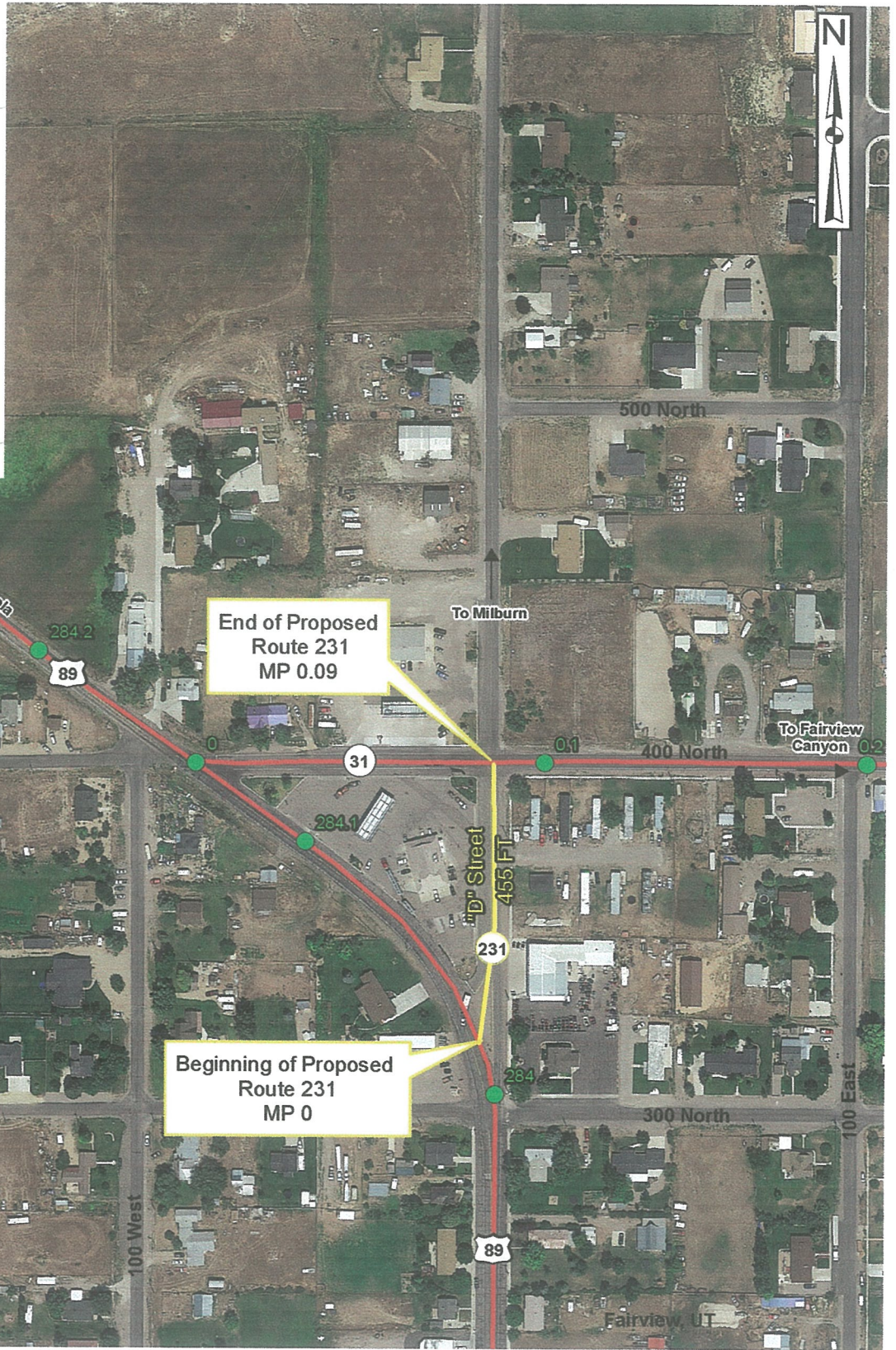
