- 3. That the east half of the old location of State Route 232 from a point from its present State Route 106 northerly to a barrier be included with a parcel of surplus property for sale to private interests.
- 4. That all the remaining portions of the old alignment of State Route 232 be obliterated and abandoned from the State System of Highways.


