From route 63 at Redwood Road west of Beck; a Hot Springs northerly and easterly to route 1 on fifth south street in Bountiful.


Recommended Description:

Comments:

Approved by Commission Action December 12, 1960 This revision changes the length at this route from 6.6 miles to 0.9 miles a decrease of 5.7 miles. The original location of route 249 was transferred to route 68 and the new location of route 249 was transferred from a portion of route 68. This was done to maintain continuity in the State Route System and to complete a truck by-pass through Davis and Salt Lake Counties.

Designation of State System

In order to provide an adequate road from the north to the Salt Lake City municipal airport, it is requested that the following road be revised as an interim designation and be included in the Federal-aid Secondary System.

Route 249, Salt Lake City

Be it resolved that the extension of State Route 219 be added as an interim designation, subject to the approval of the legislature to include an addition from the junction with State Route 68 at Redwood Road and 2100 North Street southwesterly to 2200 North Street and 2000 West Street.

This addition would increase the length of this route from 0.9 mile to 1.8 miles, an increase of 0.9 mile.
