WHEREAS, to provide access to the Brigham Young University Campus
and north Provo City and

WHEREAS, to maintain continuity in the State System of Highways

NOW THEREFORE, pursuant to the authority of Section 27-12-27, UCA,
1953, AS AMENDED, it is hereby resolved as follows:

1. That State Route 265 be extended from its present termini at
13th South and U-1, (US-91) in Orem easterly and southeasterly to State Route
7 at 1650 North in Provo.

2. That State Route 267 be deleted from the State System of Highways
and transferred to the jurisdiction of Provo City.

3. That portion of State Route 114 commencing at a point at 5th West
in Provo City easterly via Center Street to the State Mental Hospital be deleted
from the State System of Highways and transferred to the jurisdiction of Provo
City.

4. That application be made to the U. S. Department of Commerce, Bureau
of Public Roads to add the proposed extension of State Route 265 to the Federal-
aid System of Highways and delete the stub connection via 1230 North Street in
Provo from the Federal-aid System.

5. That by this action Federal-aid System mileage will be increased 1.6
miles, that State System mileage will be increased 0.2 mile and Provo City "B"
mileage will be increased 1.9 miles.

WHEREAS, to provide access from State Route 114 in Orem to the Interstate System of Highways and,

WHEREAS, to maintain continuity in the State Road System.

NOW, THEREFORE, pursuant to the authority of Sec. 27-12-27, UCA, 1953, as amended, it is hereby resolved as follows:

~~1. That State Route 75 be added as a interim designation from State Route 114, easterly via 16th North in Orem to Interstate State Route 15.~~

1. X. That State Route 52 be extended from its present terminus at Interstate Route 15 and 8th North in Orem, westerly to State Route 114.

2. X. That State Route 265 be extended from its present terminus at Interstate Route 15 and 12th South in Orem westerly to State Route 114.

3. X. That application be made to the U. S. Department of Commerce, Bureau of Public Roads to add the proposed extension of State Route 52 and State Route 265 to the Federal-aid System of Highways.

4. X. That by this action, State Highway System mileage will be increased approximately ^{1.4} 1.4 miles, and that Federal-aid System mileage will be increased approximately .9 mile.

5. X. That Exhibit "A" attached herewith illustrating the action taken herewith is hereby incorporated as a part of this submission.
