We request that the present state designation on Fourth East from Main Street to Fourth North be changed to Third East from Main Street to Sixth North, thence east to Sixth East to Fourth North, thence west back to Third East. Such a designation would encompass all of the streets around the College of Eastern Utah.





WHEREAS, officials of Price City and The College of Eastern Utah have indicated plans of expansion to the campus of The College of Eastern Utah which will create an impact on a portion of current SR-283 on 600 North from 500 East to Veterans Lane, effectively creating a need for closure of stated portion of roadway, and

WHEREAS, the Utah Transportation Commission feels it is in the best interest of the State of Utah as well as the Utah Department of Transportation through the defined actions inherent with sections 72-4-102 and 72-4-103 of the Utah Code contingent upon special compensation to the city of Price Utah defined herein, and

WHEREAS, The Region Four Director, having reviewed all material and correspondence related to the request by the officials of Price City and The College of Eastern Utah for the proposed transfer of SR-283, concurs with the actions defined herein, and

WHEREAS, the appropriate staff of the Program Development Division, reviewing the criteria for state highways and having reviewed all pertinent material and correspondence related to the proposed transfer concurs with the request of transfer by the officials of Price City and The College of Eastern Utah.

NOW THEREFORE, be it resolved as follows:

- 1. The Utah Department of Transportation abandons any and all interest pertaining to jurisdiction, operation, and maintenance of roadway legally described as SR-283 as follows: From Route 55 in Price north on Third East Street to Sixth North Street; then east on Sixth North Street to Veterans Lane: then south on Veterans Lane to Fourth North Street; then west on Fourth North Street to Third East Street, providing a peripheral road around the College of Eastern Utah a distance of 1.33± miles and depicted on Exhibit "A"
- That the legally defined roadway along with the jurisdiction, operation, and maintenance of stated facility be transferred to the jurisdiction of Price City and be placed on Price Cities "C" System of mileage.

3. The afore-mentioned roadway will continue to be Functionally Classified as follows.

With passage of this resolution the portion of roadway residing on 300 East from the Jct. with SR-55 to 600 North will be incorporated as a portion of the Federal Route System and be numbered as a portion of route number 1344.

- 4. As part of the agreement for this highway transfer, the Utah Department of Transportation will furnish a used snow plow to the City of Price. UDOT will take the actions necessary to transfer a used truck complete with snow plow and sander by selecting the best available vehicle for this purpose from those that are designated for surplus.
- 5. The Utah Department of Transportation has committed to making certain improvements on this highway before transfer including the completed drainage projects at 600 North and 4th East, at Veterans Lane and 4th North, and replaced curb and gutter on the south side of 600 North between 3th and 4th East. A project to resurface the existing SR-283 is underway as of this date and will be completed before transfer is complete.
- The statements contain within this resolution will become effective upon passage by the Utah Transportation Commission and when the actions defined in statement five are completed.
- The accompanying Letters, Memos, Emails, map and Exhibit "A" be made part of this resolution.

Subject: Closing a portion of SR-283

Attached is a letter from the College of Eastern Utah (CEU) requesting a closure of State Road 283 between 500 East and Veterans Lane. This highway and the closure is shown on the attached map. Also attached is a letter of support for the closure from the City of Price.

Price District's major concern about this closure is the loss of the loop for snow plowing. If the block is closed, snow plows will be forced to turn around and the highway or drive a greater distance on City streets to make the loop.

Information I found in the Utah Criminal and Traffic Code seems to relate to this issue.

- 1. Section 72-4-134(2) defines SR-283 as a state highway.
- Section 72-4-103 states a portion or a state highway can be deleted from the state highway system by the Legislature or the commission if the department returns the highway to the municipality or abandons it.
- SR-283 does not meet the definitions of a state highway as defined in Section 72-4-102.5.
- 4. The only thing I can find on closing highway is Section 72-7-408 which allows weight restrictions to a maximum of 90 days per calendar year and a Priority 5 season road in Policy 06A-42, Snow Removal.
 - 5. Section 72-5-103 gives the city a joint undivided interest in the title of this highway.
- Section 72-5-105 states, "All public highways once established shall continue to be highways until abandoned or vacated by order of the highway authorities having jurisdiction over any highway."

7. Interestingly, Section 53B-3-106 has this statement, "All streets, roadways, alleys, and parking lots on property owned or controlled by state institutions of higher education are 'streets and highways' as these terms are used in Title 41, Chapter 6." This paragraph seems to keep the area as a highway even if it is closed and becomes part of the college parking facilities.

Price District is not aware of a Price Street that could be made into a state highway to trade with SR-283.

Price District intends to do a contractual maintenance pavement preservation on SR-283 during the summer of 2001. This project will consist of rotomilling the existing surface to remove the open graded surface course and level the roadway and place a new open graded surface course on the highway. Therefor the road should be in good condition to give to the local authority.

I believe from the above information the Department can abandon or vacate SR-283 to the City of Price but the action will need commission action. Once Price has sole title, it can do as it wishes with the highway or streets as they then would be. It does not appear to me that Price District or Region 4 can authorize a closure, abandonment, or vacation.

If you concur, I would recommend we forward the request to the Deputy Director with a request for commission action.

When you were here in Price for the coal truck meeting we looked at closing a section of the State Highway on the north side of CEU (College of Eastern Utah).

I have visited with Roy Nikas Price City Council about transferring SR-283 around College of Eastern Utah to Price City. He want us to confirm that if Price City takes the road it will be placed on their B & C road fund list. There were two drainage issues he felt we should address and we should resurface either before we give or agreee to do so after the CEU building is finished. The drainage and resurfacing are things we can do with or contractual maintenance money. If after the transfer there would need to be a written agreement that we will do the work. The other thing he mentioned is: would UDOT contribute a use (fairly good) snow plow (he said 10 wheeler) to the City fleet. That question is also beyond my ability to do but is of some interest. Can I have your feelings about the B roads funds and the truck. I have a follow up meeting planned for the week of April 16th.

Dear Mayor Colosimo:

CEU has requested UDOT close 600 North between 500 East and Veterans Lane. State Law and UDOT policy allows road closures of 90 days for weight restrictions and seasonal closures for snow. We cannot permanently block or close the road unless it is done as outlined in Section 72-5-105 of Utah Code.

The road can be deleted from the state system by the Legislature or Highway Commission if the highway is returned to the municipality or is abandon.

I have met with Roy Nikas' committee, and we have discussed several issues about Price accepting the street.

- Drainage at 600 North and 4th East: We have a contractor that will put inlets in this intersection and pipe that flows to an existing pipe in 3rd East. We will replace the curb and gutter on the south side of 600 North between 3rd and 4th East. This work will be done this summer. The preconstruction meeting is July 18, 2001.
- Drainage at Veterans Lane and 4th North has been corrected by a cooperative project between UDOT and Price City.
 - 3. If the City accepts the roadway, it will be added to the City's Class C Roads.
- 4. We have a contract to resurface SR-283 this summer. If CEU's construction program will impact an area of the highway, we can delay and do it later. However, we are planning to do the entire road. Again the preconstruction meeting is July 18.

- 5. If Price wants the highway, it can be conveyed with no deed restrictions.
- 6. UDOT is reviewing providing a snow plow to the City should you accept the road. The plow we use on this road is a six wheel truck with plow and sander. It would be about four years old. The "giving" of State assets is a new experience, and we want to be sure it is done correctly so neither agency is embarrassed.

One problem with just closing the one block is UDOT would no longer have a circular snow plow route.

Other options would able to trade SR-283 for some other road that meets the defined in Utah Code 72-4-102.5. This could even be a trade involving Carbon County.

The City or CEU could request the Legislature to change State law as it relates to this highway. This would change the Code Section 72-4-134(2) that defines the route of SR-283.

I do not have a problem with closing or abandoning the road or transferring ownership to the City or CEU. Proper authorities, in this case, are both the City and State who need to vacate or abandon the road. You may wish to schedule the appropriate meeting.

College of Eastern Utah has received the July 13, 2001 letter from Kleston Laws regarding our request for the closure of 600 North between 500 East and Veterans Lane. The College would like to ask Price City to consider the options to acquire SR 283 from the state. This request is based on the following:

- 1. At a public hearing held by Price City Planning and Zoning the residents located north of 600 North and east of 500 East expressed their concern about the traffic patterns of both college students and high school students who attend classes in the Career Center Building and use 600 North as a thorough fare. The residents agreed that the use of barricades to close the street at 500 East and 600 North would redirect traffic patterns and eliminate much of the concern they feel.
- 2. The College has received funding for the construction of a parking area to be located on the old Durrant School property. The construction of that parking area will be completed by late fall of 2001. As we begin construction of the main building replacement, the main parking lot located on 400 North will be closed. If 600 North is closed at the corner of 500 East, we will be able to redirect traffic to Veterans Lane to access the new parking area. If that closure does not occur it is likely CEU traffic will proceed up 300 east, across 600 north to the new parking area which is a significant increase for the residents of that area.

The College would also recommend that the UDOT re-paving of 400 North, which is scheduled to occur this month, be delayed until the construction of the main building replacement is completed. It is also seems appropriate for the College to request UDOT to use the 90-day temporary closure during the period of time it takes for the full transfer. At this time we understand that Carbon High School football games will be played on the college football field which will generate additional traffic in the neighborhood. The first football game is scheduled for August 17.

Page 2 letter to Mayor Lou Colosimo

I have discussed the above options and alternatives with Councilperson Roy Nikas and Public Works Director Gary Sonntag to assure that this request and the transfer of SR 283 would be appropriate for the City. While this request for closure of 600 North between 500 East and Veterans Lane has been a topic of discussion for approximately two years, there now is an urgent need to proceed as quickly as possible. Because the new traffic patterns created by CEU construction/parking area, and Carbon High school use of the football field will create safety hazards for residents, vehicle traffic and pedestrians. Your consideration of this request is appreciated.

Attached are copies of correspondence regarding the conveying of title for State Road 283 to the Price City. They will then close one block to accommodate expansion of the College of Eastern Utah campus.

I understand the Commission needs to take action to convey title to Price City. It would be nice to have this on the August 24th Commission Agenda. The college would really like to have the physical closure in place prior to the start to school. Two other actions will need to take place. One adding the road to the B and C road funds and having the legislature delete the road from the Utah Code. I believe this action complies with Section 72-4-102 and 72-4-103 of the Utah Code. Commissioner Wilson is aware of this action.

The only complication in giving the highway to the City is their insistence on getting a snow plow to go with the deal. We are identifying several trucks that will be acceptable to the District to be offered to Price City. They will consist of 'bobtail' trucks and 10 wheel trucks that are eligible for trade in. We agree to use a temporary assigned truck from the motor pool until the District equipment budget can replace the truck permanently.
