WHEREAS, Mr. W. E. Mickelson, District Engineer, concurs with this request as it is in keeping with the continuing development of a unified road system at the Weber State College, and

WHEREAS, the Utah State Department of Highways has programmed funds for this portion of a peripheral road at the Weber State College,

NOW THEREFORE, be it resolved as follows:

That State Route 284 be modified to include a proposed roadway from a connection with 41st Street northerly paralleling Harrison Boulevard (State Route 203) on the east side to a connection with Harrison Boulevard at 37th Street in Ogden as a part of the peripheral road at Weber State College and be designated as a part of State Route 284, Sub-section (e).

That by this action State Highway System mileage will increase 0.6 + - mile,

That the letter from Weber State College and the memorandum from Mr. W. E. Mickelson pertaining to this subject road be hereby incorporated as a part of this submission and

- SUBJECT: Addition to the Peripheral Road System for Weber State College

Attached is a letter from Mr. Fred Johnson, Director of Campus Planning for Weber State College. He is requesting certain additions to the state road system within the campus area.

This office has been cooperating for several years with the officials of Weber State College to upgrade their existing roads that are on the state system and to develop a unified plan for additional roads, relocations, and deletion or transfers of other roads as they continue to experience a period of tremendous growth. Access from Harrison Boulevard has also been thoroughly studied since this is the major feeder to the campus.

The Highway Department has now programmed \$250,000 for a new section of peripheral road as shown in red on the attached map. We solicit your help now to place this proposed road on the state system. Other sections will be proposed, in the future, for addition, and some of the existing system will be deleted, however, this is the only appropriate action to be undertaken at this time.

Dear Mr. Mickelson:

This letter is to confirm a discussion I had with Mr. Richardson, of your department, relative to the future development of Weber State College and the road system required to handle an anticipated 4,000 to 5,000 automobiles on this piece of State property.

I am enclosing a copy of a recently developed master plan which I have discussed with Mr. Richardson. On this plan I have outlined two legs of a proposed peripheral road system which I feel are crucial and should be completed as quickly as possible. However, before construction could begin all of the property would have to be acquired by Weber State College for the right-of-way to be granted.

In the meantime, however, Mr. Richardson informed me that it would be possible to have a survey crew at least stake out the center line of the proposed road and thereby determine the feasibility of same and arrive at a budget figure to which we could work and decide if it would be possible to schedule all or a portion of this work into your 1968 budget.

I also discussed with Mr. Richardson, and he could further explain the details to you, the necessity we feel to develop at least one, and possibly two, non-stop right hand turn acceleration lane onto Harrison Blvd. from the main entrance to Weber State College campus. At peak periods during the day, because of the problem with left hand turns, traffic piles up in these entrances, making right or left exits from the campus virtually impossible, and at best extremely time consuming. 

Subject: Transfer of a portion of the old alignment of State Route 39 and the addition of State Route 284 in Ogden City

On September 11, 1970, the Utah State Road Commission adopted a resolution to transfer portions of the old alignment of State Route 39 created by the construction of Project SU-0568(6) to the jurisdiction of Ogden City.

On this same date the Utah State Road Commission adopted a resolution to add to State Route 284 a proposed roadway from 41st Street northerly paralleling Harrison Boulevard (State Route 203) to a connection with Harrison Boulevard at 37th Street.

By this action Ogden City "C" mileage will increase 0.4 + - mile. Attached is a copy of the resolutions and the location maps.

NOW THEREFORE, be it resolved as follows:

That the portion of State Route 284, Sub-section 3, from State Route 203 east via Edvalson Street to the proposed north-south Peripheral Road be deleted,

That the portion of State Route 284, Sub-section 1, from the proposed north-south Peripheral Road east via 3850 South Street to the parking area near the College Stadium be deleted, .

That State Route 284, Sub-section 2, from 3850 South Street north to Edvalson Street be deleted,

That a proposed connection from State Route 203 east via 40th South Street to the proposed north-south Peripheral Road be added to State Route 284 as Sub-section 2,

That as a result of the aforementioned revisions State Route 284 at the Weber State College Campus will be as follows:

Sub-section 1: From State Route 203 east via 3850 South Street to the north-south Peripheral Road.

Sub-section 2: From State Route 203 east via 40th South Street to the north-south Peripheral Road.

Sub-section 3: From the north-south Peripheral Road east via Edvalson Street to Skyline Drive.

Sub-section 4: From State Route 203 easterly via 41st South Street to Taylor Avenue.


