#### RESOLUTION

### Revision of State Route 289

WHEREAS, the campus at the Southern Utah State College in Cedar City has been expanding to the west, and

WHEREAS, it is the policy of the Utah Transportation Commission to provide State designated peripheral roads at State Institutions, and

WHEREAS, the Officials of the College and Cedar City have requested that State Route 289 be extended from a point at 8th West and Center Street west to 1150 West Street, thence south via 1150 West Street to 2nd South Street, thence east to 8th West Street.

NOW THEREFORE, be it resolved as follows:

That State Route 289 be extended from a point at 8th West and Center Street west to 1150 West Street, thence south via 1150 West Street to 2nd South Street, thence east to 8th West Street,

That by this action present State Route 289 between Center Street and 2nd South Street on 8th West Street be deleted from the State System of Highways and transferred to the jurisdiction of Cedar City,

That by this action that portion of Collector Road 20 presently on 1150 West Street and 2nd South Street, a distance of 0.30 + - mile be deleted from the Collector Road System, and by this action decrease the Collector Road System mileage from 2,552.1 to 2,551.8 miles,

That this action become effective upon the completion of the present construction projects on 1150 West Street and 2nd South Street,

That by this action the State Highway System mileage will increase 0.46 + - mile and Cedar City "C" mileage will decrease 0.46 + - mile.


