WHEREAS, to clarify maintenance responsibility for those roads at the Browning Armory in South Ogden that are used for the purpose of a physical test for automotive drivers ability, and

WHEREAS, those roads that are to be used for driving tests have been coordinated with the Utah State Department of Public Safety, Drivers License Division and Mr. Bert Taylor, District Engineer, and

WHEREAS, these roads are considered as a part of the State System of Highways.

NOW THEREFORE, be it resolved as follows:

That the roads at the Browning Armory in South Ogden that are used for the purpose of a physical test for automotive drivers ability are a part of the State Road System and designated as State Route 298,

That the parking areas be considered part of this route for maintenance responsibility,

That by this action State Highway System mileage will increase 1.0 + - mile,

On April 18, 1969 the State Road Commission designated the driver's test course at the Utah State Fairgrounds as State Route 297 (the purpose being for snow removal).

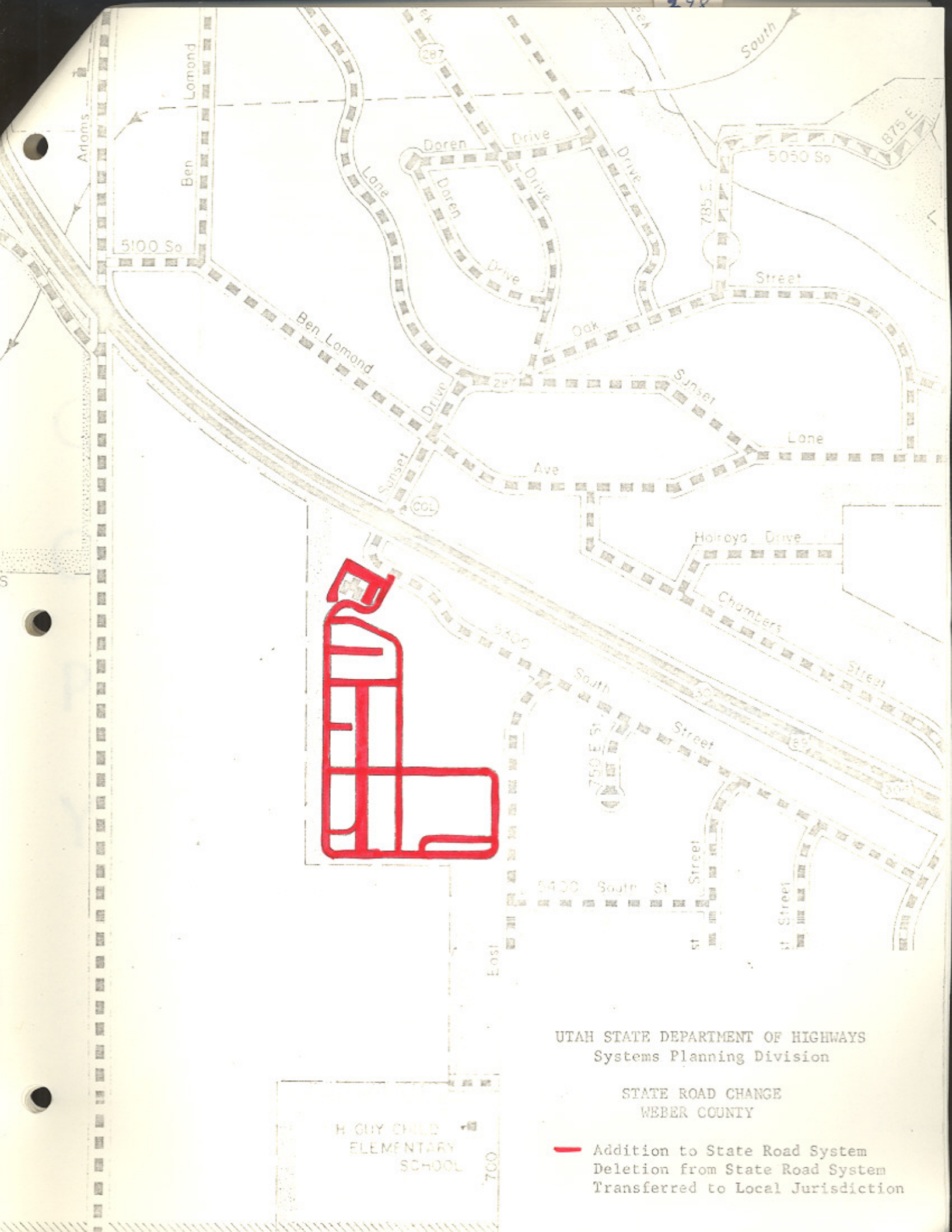
