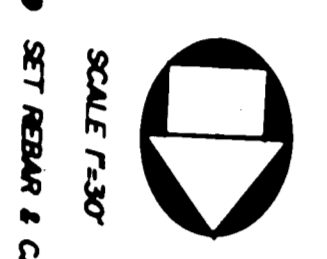
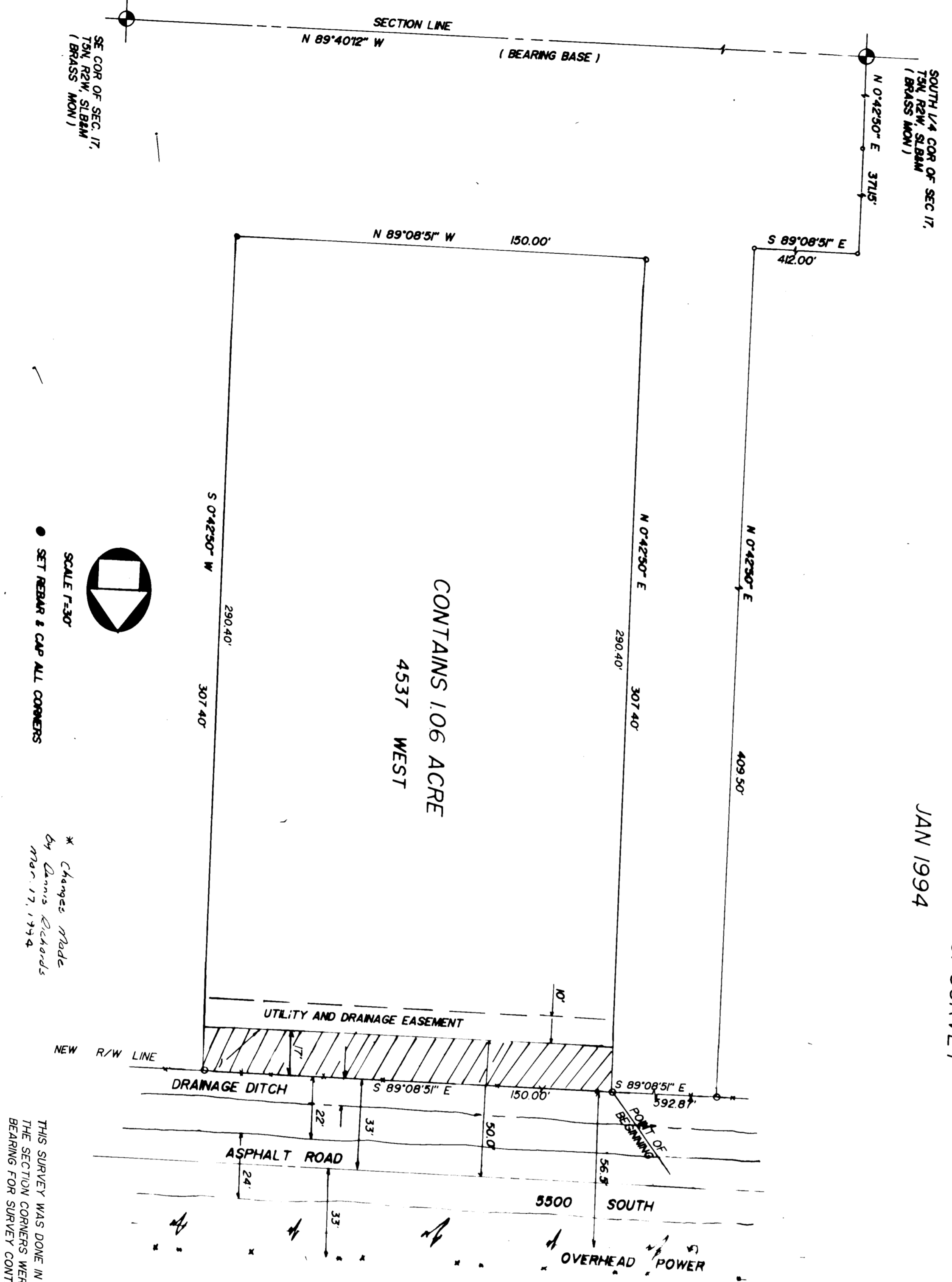


COUNTRY GOLD ESTATES
