A PART OF THE SOUTHWEST QUARTER OF SECTION 19 AND THE NORTHWEST QUARTER OF SECTION 30, TOWNSHIP 6 NORTH, RANGE 1 WEST, SALT LAKE BASE AND MERIDIAN. BASIS OF BEARINGS IS STATE PLANE GRID BEARING OF S. 01° 28' 19" W. ALONG THE 1983 WEBER COUNTY MONUMENTED WEST LINE OF THE NORTHWEST QUARTER OF SAID SECTION 30. THE 1963 WEBER COUNTY SURVEYORS MONUMENTED NORTHWEST CORNER OF SAID SECTION 30 LIES PER WEBER COUNTY SURVEYORS RECORDS S. 22° 16' 24" W. 69.05 FEET OF THE 1983 NORTHWEST MONUMENTED CORNER OF SAID SECTION 30.

(EAST) 80.50 FEET MORE OR LESS TO A FENCE, THENCE N. 0° 51' 15" E. 219.21 FEET ALONG SAID FENCE TO A FENCE CORNER, THENCE N. 0° 47′ 55" E. 258.94 FEET TO THE SOUTH END OF A FENCE, THENCE N. 01° 38′ 44" E. 153.99 FEET ALONG AND BEYOND SAID FENCE TO A POINT WHICH BEARS N. 89° 51' 14" W. THE PURPOSE OF THIS DESCRIPTION IS TO DESCRIBE AN EXISTING PARCEL OF GROUND FOR THE SELLING OF, DEEDS IN THIS QUARTER SECTION HAVE BEEN WRITTEN FROM THE 1963 AND THE 1983 LOCATION OF THE WEST LINE OF SAID QUARTER SECTION AND HAVE CAUSED AN UNCERTAINTY OF SOME OF THEIR LOCATIONS. WE ARE PROPOSING A BOUNDARY LINE AGREEMENT ON THE WEST LINE OF THE ABOVE DESCRIBED PROPERTY, USING OLD EXISTING

FENCE LINES TO CREATE THIS BOUNDARY LINE AGREEMENT. THE FENCE LINE THAT HAS BEEN PROJECTED NORTH TO THE SOUTH BANK OF THE RIVER HAS BEEN USED IN THE ABSENCE OF A SLOUGH THAT HAD BEEN CALLED FOR IN A DEED, THIS FENCE HAS BEEN USED WITH THE KNOWLEDGE THAT THERE WAS A FENCE ON THE EAST SIDE OF THIS SLOUGH, THE SLOUGH HAS BEEN FILLED IN AND THE FENCE ON ITS EAST SIDE HAS BEEN TAKEN DOWN FOR SOME TIME NOW. SINCE THERE IS UNCERTAINTY AS TO THE LOCATION OF THE NORTHWEST QUARTER OF SAID SECTION 30, IN AN EAST-WEST AND NORTH-SOUTH DIRECTION, THIS COULD BE THE ONLY EVIDENCE OF
