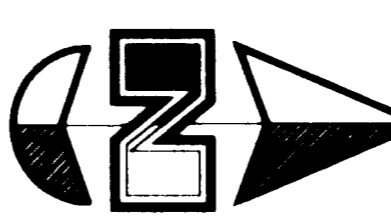

**DESCRIPTIONS**

**PARCEL NO. 1**  
A part of the Northwest Quarter of Section 16, Township 6 North, Range 1 West, Salt Lake Meridian, U.S. Survey, 808.08 feet East and 220 feet North from the beginning of Corner of said Quarter Section; said point being 187 feet North from the North line of 2nd Street, Ogden City, Weber County, Utah; and running thence North 47 feet, thence East 180.55 feet; hence South 47 feet, thence West 270.55 feet to the place of beginning.

**PARCEL NO. 2**  
A part of the Northwest Quarter of Section 16, Township 6 North, Range 1 West, Salt Lake Meridian, U.S. Survey, 808.08 feet East and 212 feet North from the Northwest Corner of said Quarter Section; said point being 214 feet thence East 180.55 feet; hence North 47 feet; hence East 90 feet; hence South 55 feet; hence West 270.55 feet to the place of beginning.

**PARCEL NO. 3**  
A part of the Northwest Quarter of Section 16, Township 6 North, Range 1 West, Salt Lake Meridian, U.S. Survey, 808.08 feet East and 267 feet North from the Northwest Corner of said Quarter Section; said point being 214 feet thence East 180.55 feet; hence North 47 feet; hence East 90 feet; hence South 55 feet; hence West 270.55 feet to the place of beginning.
