

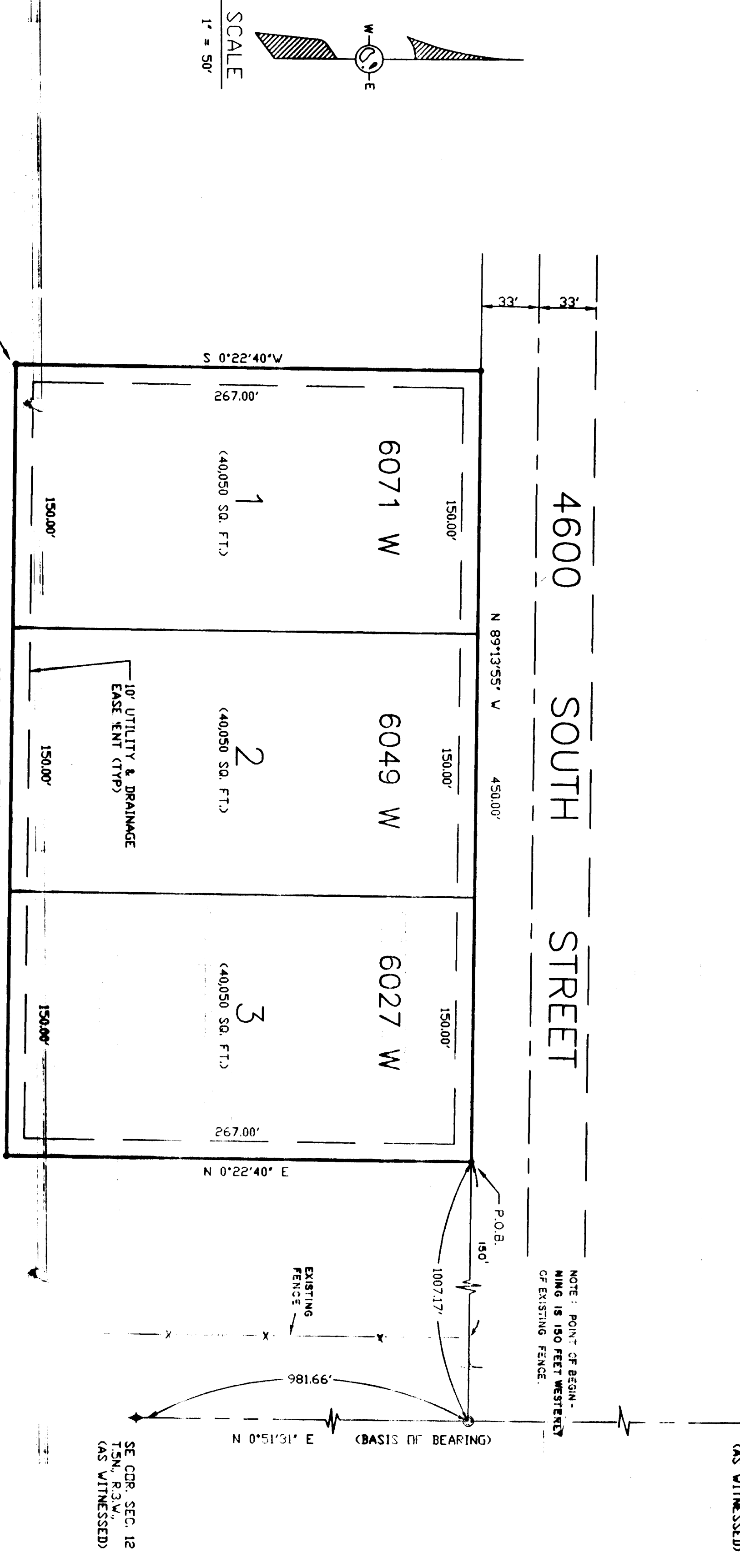

ARE SHOWN HEREON.

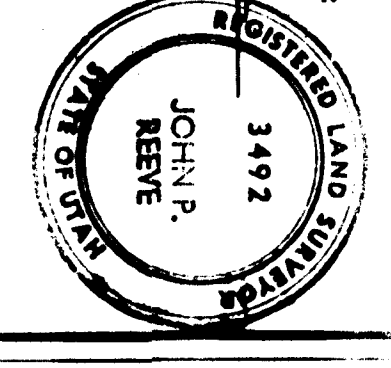
