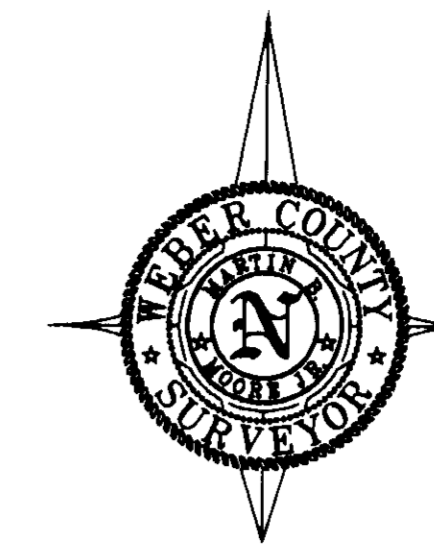
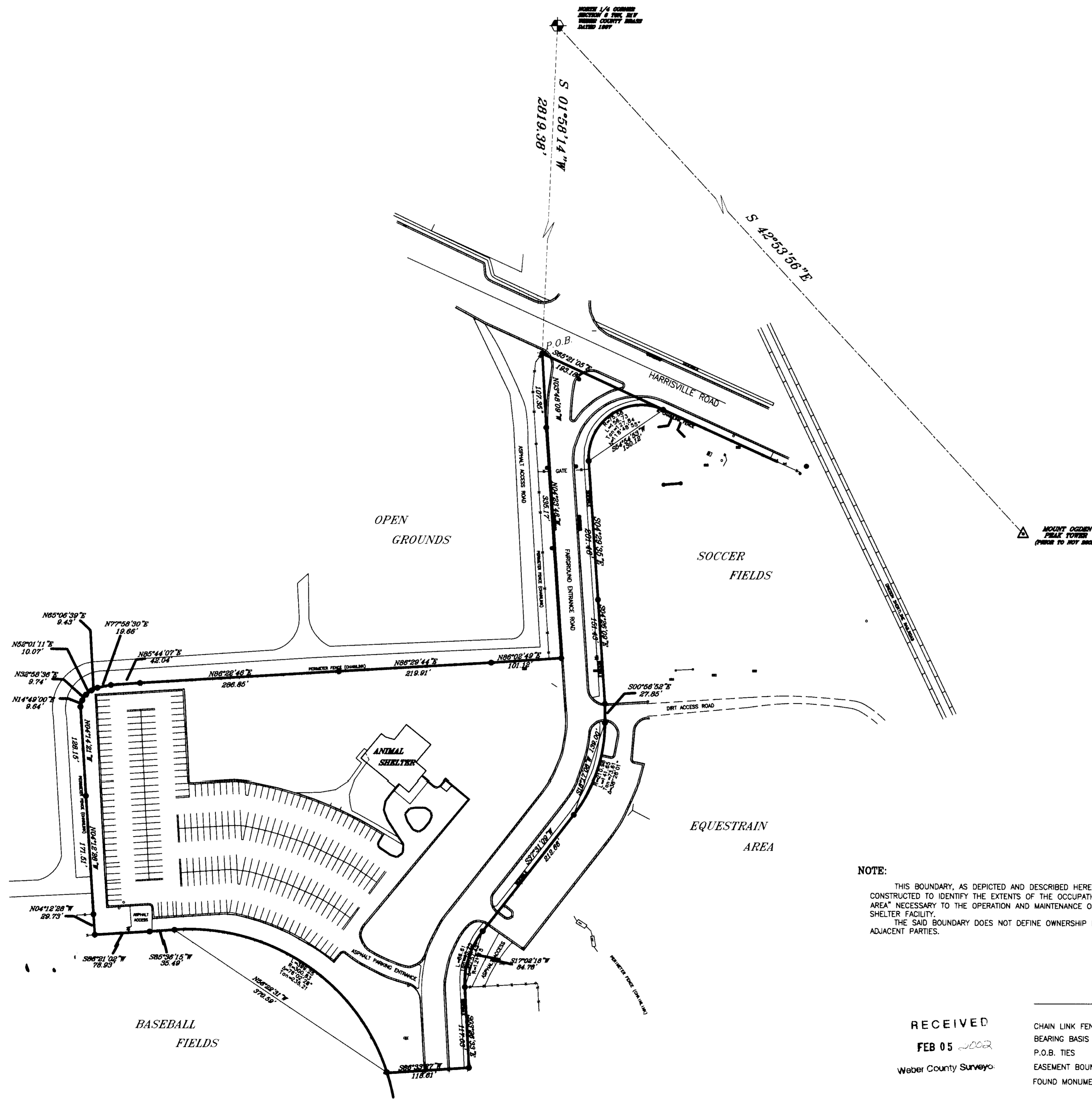


# ANIMAL SHELTER ACCESS EASEMENT

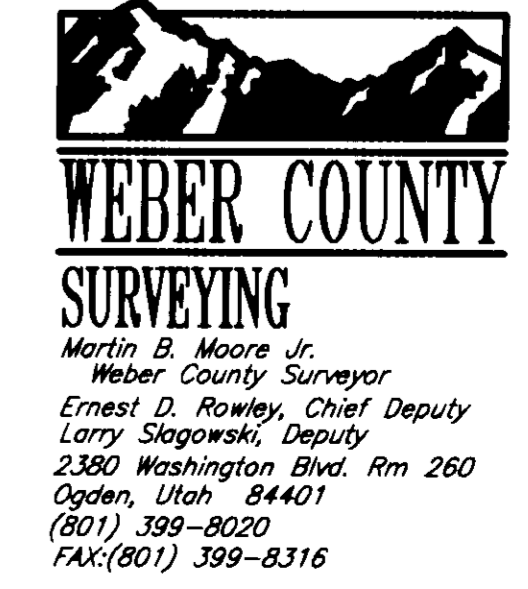
**WEBER COUNTY SURVEYOR'S CERTIFICATE**

MOORE JR., HAVING BEEN DULY ELECTED AS THE WEBER COUNTY SURVEYOR DO HEREBY CERTIFY THAT WE OF THE WEBER COUNTY SURVEYOR'S OFFICE, OF THE STATE OF UTAH, HAVE MADE A SURVEY OF THE TRACT OF LAND SHOWN HEREON. THAT THIS PLAT HAS BEEN PREPARED FROM THE ORIGINAL FIELD NOTES MADE DURING A SURVEY OF THIS TRACT OF LAND AND THAT THIS PLAT IS AN ACCURATE RECORD OF THIS SURVEY.



**BASIS OF BEARING**  
THE BASIS OF BEARING FOR THIS SURVEY IS THAT OF THE 1927 UTAH STATE PLANE COORDINATE SYSTEM, SAID BASIS BEING SOUTH 42°53'56" EAST BETWEEN THE NORTH QUARTER CORNER OF SECTION 6, TOWNSHIP 6 NORTH, RANGE 1 WEST AND THE ERECTED MOUNT OGDEN TOWER (PRIOR TO NOVEMBER 2001).

**BOUNDARY DESCRIPTION**  
PART OF THE SOUTH HALF OF SECTION 6, TOWNSHIP 6 NORTH, RANGE 1 WEST, SALT LAKE BASE AND MERIDIAN, U.S. SURVEY DESCRIBED AS FOLLOWS:  
BEGINNING AT A POINT THAT FALLS SOUTH 01°58'14" WEST 2819.38 FEET FROM WEBER COUNTY BRASS CAP REPRESENTING THE NORTH QUARTER CORNER OF SECTION 6, TOWNSHIP 6 NORTH, RANGE 1 WEST—BASIS OF BEARING BEING SOUTH 42°53'56" EAST (NAD'27) BETWEEN THE SAID NORTH QUARTER CORNER OF SECTION 6 AND THE ERECTED MOUNT OGDEN PEAK TOWER (PRIOR TO NOVEMBER 2001)— SAID POINT BEING AT A FENCE CORNER REPRESENTING THE APPARENT SOUTH RIGHT OF WAY LINE OF HARRISVILLE ROAD, AND RUNNING:  
THENCE SOUTH 65°21'05" EAST ALONG THE APPARENT SOUTH RIGHT OF WAY LINE 193.18 FEET,  
THENCE: SOUTHWESTERLY 156.73 FEET ALONG THE ARC OF A CURVE TO THE LEFT (SAID CURVE RUNS ALONG AN EXISTING CHAINLINK FENCE) HAVING A RADIUS OF 75.58 FEET AND A CENTRAL ANGLE OF 118°48'55". LONG CHORD BEARS SOUTH 54°54'53" WEST 130.12 FEET, RUNNING THENCE PARALLEL WITH (AND APPROXIMATELY 1.00 FOOT EAST OF) THE EAST EDGE OF AN EXISTING CONCRETE WALK, THE FOLLOWING 7 COURSES:  
THENCE: SOUTH 04°29'35" EAST 201.46 FEET,  
THENCE: SOUTH 04°26'09" EAST 151.43 FEET,  
THENCE: SOUTH 00°56'52" EAST 27.85 FEET,  
THENCE: SOUTHWESTERLY 141.65 FEET ALONG THE ARC OF A CURVE TO THE RIGHT HAVING A RADIUS OF 210.98 FEET AND A CENTRAL ANGLE OF 38°28'01". LONG CHORD BEARS SOUTH 18°17'08" WEST 139.00 FEET,  
THENCE: SOUTH 37°31'09" WEST 212.66 FEET,  
THENCE: SOUTHERLY 86.61 FEET ALONG THE ARC OF A CURVE TO THE LEFT HAVING A RADIUS OF 121.15 FEET AND A CENTRAL ANGLE OF 40°57'42". LONG CHORD BEARS SOUTH 17°02'18" WEST 84.78 FEET,  
THENCE: SOUTH 03°26'33" EAST 117.03 FEET,  
THENCE: LEAVING THE SAID WALK AND RUNNING SOUTH 86°33'27" WEST 118.61 FEET TO THE INTERSECTION WITH AN EXISTING CHAINLINK FENCE, RUNNING THENCE ALONG THE ALIGNMENT OF AN EXISTING CHAINLINK FENCE THE FOLLOWING THREE COURSES:  
THENCE: NORTHWESTERLY 399.25 FEET ALONG THE ARC OF A CURVE TO THE LEFT AND HAVING A RADIUS OF 300.83 FEET AND A CENTRAL ANGLE OF 76°02'28". LONG CHORD BEARS NORTH 56°22'31" WEST 370.59 FEET,  
THENCE: SOUTH 85°36'15" WEST 35.49 FEET,  
THENCE: SOUTH 86°21'02" WEST 78.93 FEET,  
THENCE: LEAVING THE SAID CHAINLINK FENCE AND RUNNING NORTH 04°12'28" WEST 29.73 FEET TO THE SOUTH END OF AN EXISTING CHAINLINK FENCE, RUNNING THENCE ALONG THE ALIGNMENT OF THE SAID CHAINLINK FENCE THE FOLLOWING 11 COURSES:  
THENCE: NORTH 04°12'28" WEST 171.51 FEET,  
THENCE: NORTH 04°14'21" WEST 128.15 FEET,  
THENCE: NORTH 14°49'00" EAST 9.64 FEET,  
THENCE: NORTH 32°58'36" EAST 9.74 FEET,  
THENCE: NORTH 52°01'11" EAST 10.07 FEET,  
THENCE: NORTH 65°06'39" EAST 9.43 FEET,  
THENCE: NORTH 77°58'30" EAST 19.66 FEET,  
THENCE: NORTH 85°44'07" EAST 42.04 FEET,  
THENCE: NORTH 86°22'46" EAST 286.85 FEET,  
THENCE: NORTH 86°29'44" EAST 219.91 FEET,  
THENCE: NORTH 86°02'49" EAST 101.12 FEET TO THE BACK OF THE EXISTING CURBING,  
THENCE: NORTH 04°23'48" WEST ALONG THE SAID BACK OF CURBING 335.17 FEET,  
THENCE: LEAVING THE BACK OF CURBING AND RUNNING NORTH 03°48'09" WEST 107.35 FEET TO THE POINT OF BEGINNING.  
CONTAINS 7.50 ACRES.
