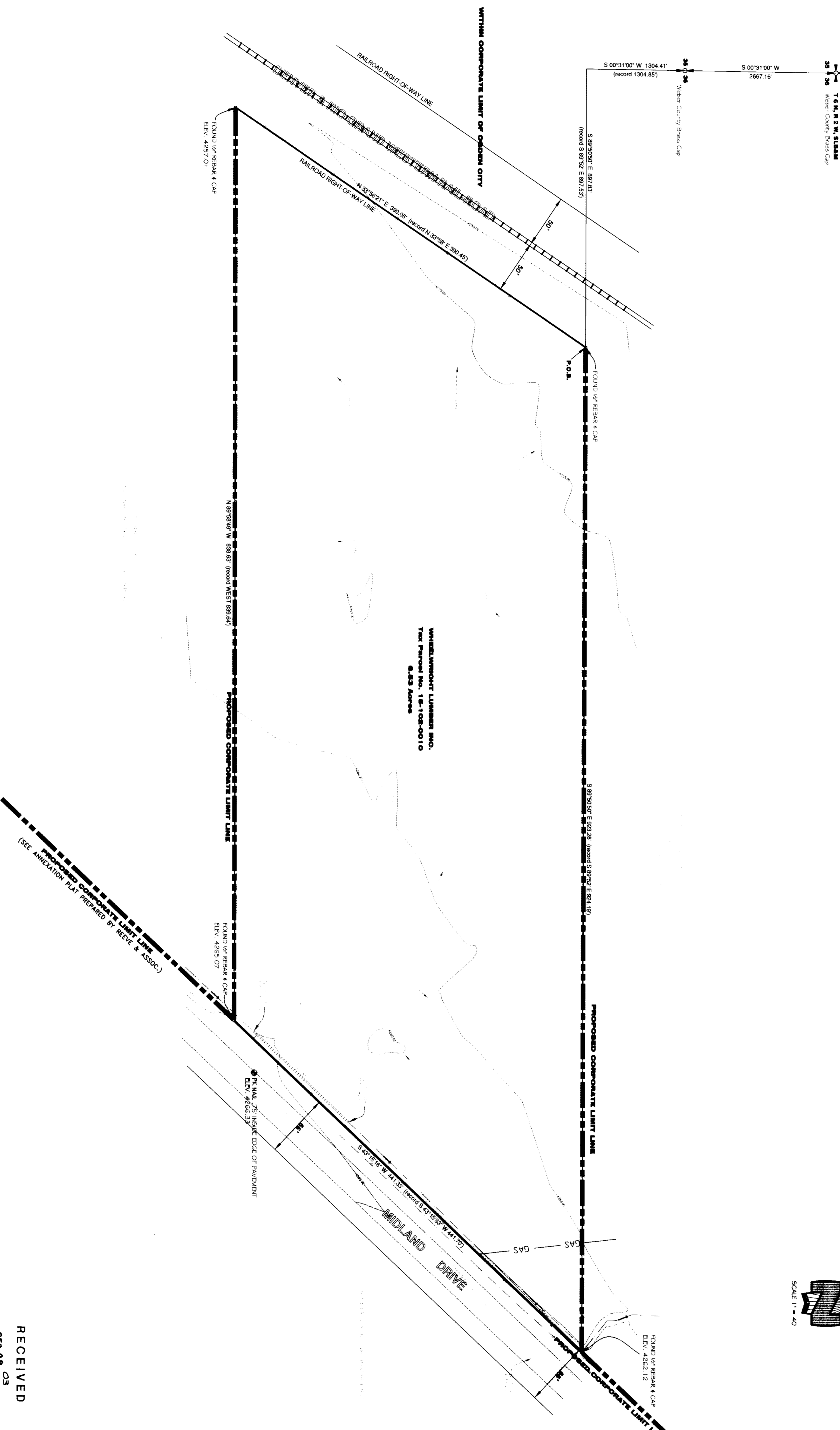


**Plat of Annexation to
