

NARRATIVE

THE PURPOSE OF THIS SURVEY WAS TO DETERMINE THE OVERALL BOUNDARY OF FOUR (4) SEPARATE PARCELS AND THEN TO CREATE A DIVISION OF THAT PARCEL LEAVING 5.25 ACRES AT THE STREET AND THE REMAINING FOR POSSIBLE SALE TO THE ADJOINER. THE AREA HAS MAJOR ISSUES WITH DEED CALLS AND OCCUPATION LINES. I HAVE ATTEMPTED TO RECOGNIZE THOSE OCCUPATIONS WHILE INCORPORATING AS MANY ELEMENTS OF DEEDS AS POSSIBLE. BASIS OF BEARING IS STATE PLANE GRID BEARING BETWEEN THE REFERENCE MONUMENT IN 1200 WEST ST. AND THE SOUTHEAST CORNER OF SECTION 12, WITH AN ADDITIONAL TIE TO THE MONUMENT AT INTERSECTION OF 200 SOUTH ST. AND 1200 WEST ST.
