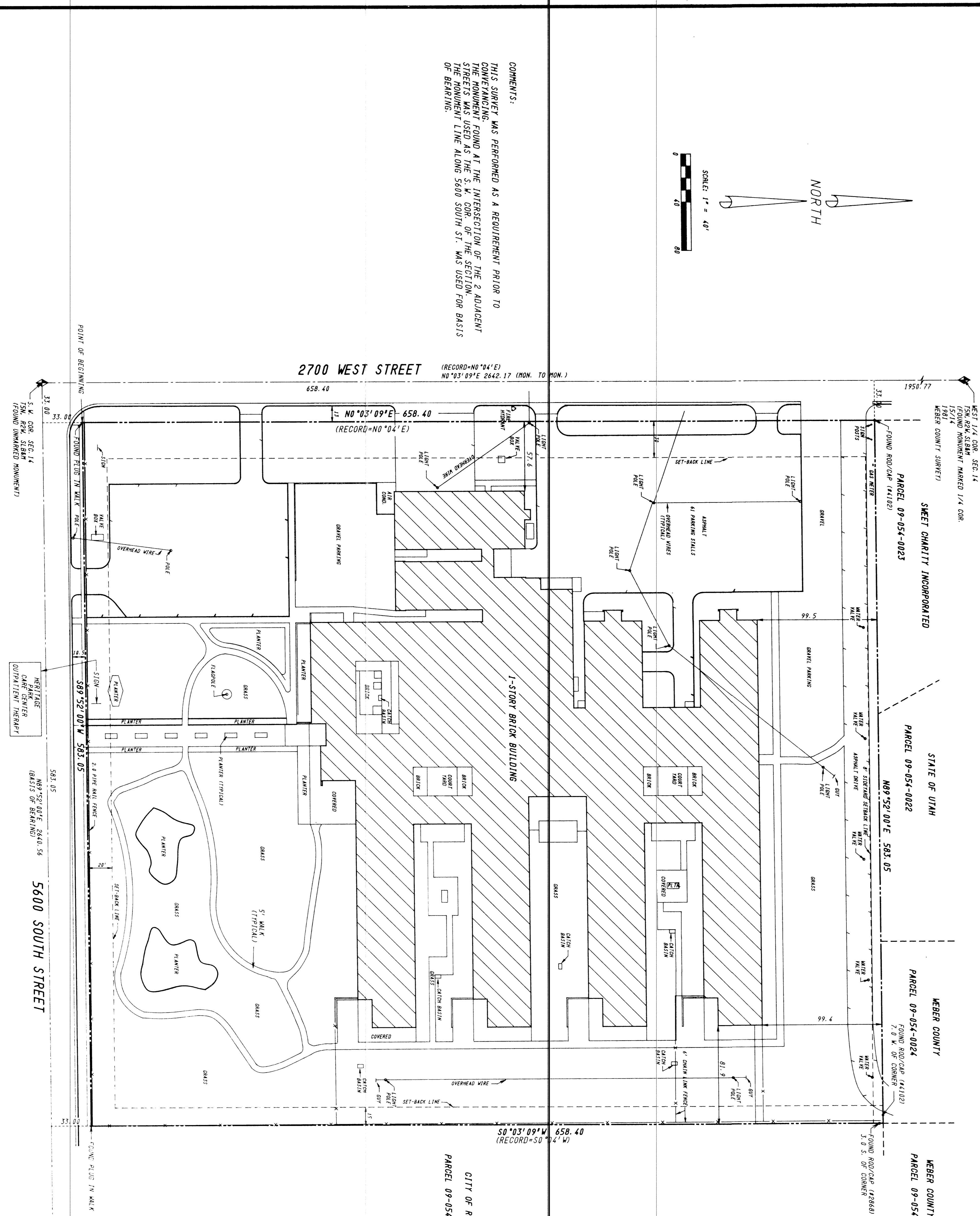


COMMENTS:
