
## RECORD OF SURVEY

## NARRATIVE:

This survey was requested by Gus Gene Hansen for the purpose of establishing the location of the boundaries of the subject property, as shown. Weber County Survey monuments were found, as shown on plat, and used to assist in determining the location of the right-of-ways and boundaries of the survey as shown. Acquiescence to an old wood rail and post fence line on the north side and acquiescence to an old barbed wire and post fence line on the west side of the HD White Family LLC property were held as the boundary lines between the said property and the subject property. Various surveys of properties in the area were drafted, located and used to assist in the location of the east right-of-way line of Utah State Route 126. A line bearing S 00°56'41" W between the Northeast corner and East quarter corner of Section 2 was held as the basis of bearing.






## **BOUNDARY DESCRIPTION**

BEGINNING AT A POINT ON THE INTERSECTION OF A NEW VINYL FENCE LINE AND A BARBED WIRE AND POST FENCE LINE: SAID POINT BEING S 00'56'41" W 2,564.27 FEET ALONG THE MONUMENTED EAST SECTION LINE OF THE NORTHEAST QUARTER OF SAID SECTION 2 AND WEST 501.87 FEET FROM THE NORTHEAST CORNER OF SAID SECTION 2; RUNNING THENCE
