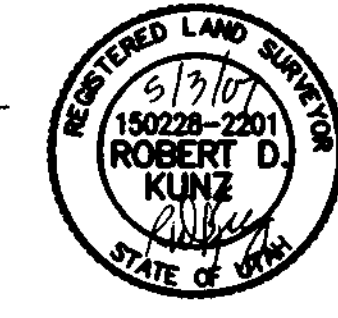


Surveyor's Certificate

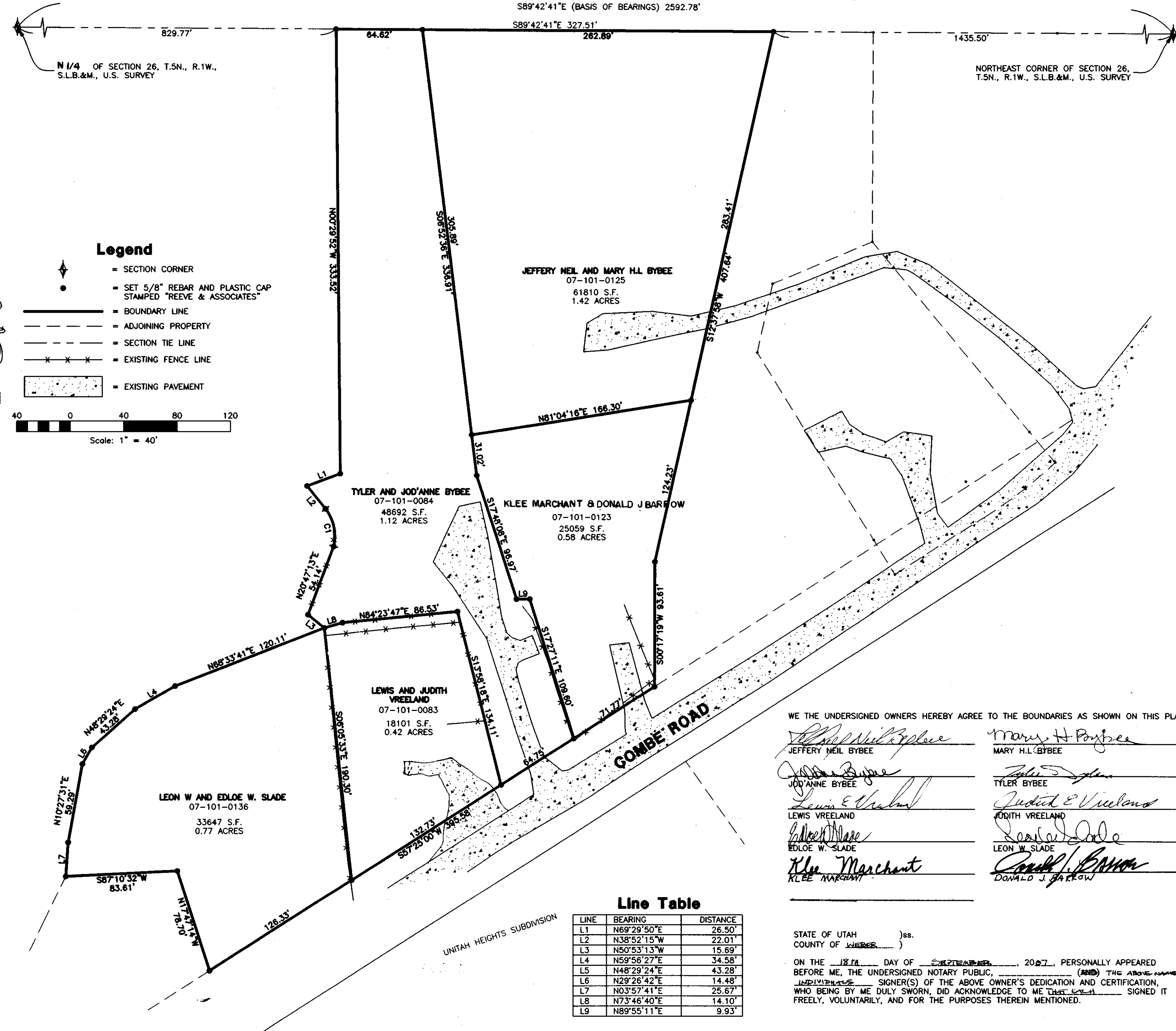
