THE BASIS OF BEARINGS FOR THIS PLAT IS EXISTING SUBDIVISION STREET IMPROVEMENTS OF RIVER VALLEY SUBDIVISON NO. 4 BEING SOUTH 87'10'30" EAST ALONG 4350 SOUTH STREET.

Narrative

THE PURPOSE OF THIS PLAT IS TO DETERMINE THE BOUNDARY OF THE BELOW DESCRIBED PROPERTY. ALL BOUNDARY CORNERS WERE SET WITH A %" REBAR AND PLASTIC CAP STAMPED "REEVE & ASSOCIATES". THE NORTH LINE WAS DETERMINED BY THE SOUTH LINE OF RIVER VALLEY SUBDIVISION NO. 3. THE SOUTH LINE WAS DETERMINED BY THE NORTH LINE OF 4350 SOUTH STREET. THE EAST AND WEST LINES WERE DETERMINED BY DEED. SURVEY REQUESTED BY BIG SKY CONSTRUCTION.


