
PROPERTY SURVEY

T5N. RIW. S.L.B. & M., AND DESCRIBED AS FOLLOWS:

BEGINNING AT A POINT ON THE WEST LINE OF HARRISON BOULEVARD SAID POINT BEING S.01°03'30"W., 1080.56 FEET AND N.89°02'00"W.. 28.48 FEET, FROM THE NE CORNER OF SAID SECTION 4, SAID POINT ALSO BEING S.00°58'00"W.. 463.80 FEET AND N.89°02'00"W.. 50.00 FEET. FROM THE OGDEN CITY SURVEY MONUMENT AT THE INTERSECTION OF 3300 SOUTH STREET AND HARRISON BOULEVARD, AND RUNNING:

THENCE S.00°58'00"W., ALONG THE WEST LINE OF HARRISON BOULEVARD. 12.00 FEET;

THENCE N.89°02'00"W., ALONG A LINE WHICH PASSES 4.92 FEET NORTH OF THE NORTHEAST CORNER OF THE EXISTING STRUCTURE LYING SOUTH OF THIS EASEMENT, A DISTANCE OF 87.14 FEET;

THENCE N.00°58'00"E.. 12.00 FEET;

THENCE S.89°02'00"E.. ALONG A LINE WHICH PASSES 2.56 FEET SOUTH OF THE SOUTHWEST CORNER OF THE STRUCTURE LYING NORTH OF THIS EASEMENT AND ONE FOOT SOUTH OF A CHIMNEY ON SAID STRUCTURE, A DISTANCE OF 87.14 FEET TO THE POINT OF BEGINNING.

BEING A PART OF THE NORTHEAST OUARTER OF SECTION 4. TOWNSHIP 5 NORTH, RANGE 1 WEST, SALT LAKE BASE AND MERIDIAN, AND DESCRIBED AS FOLLOWS:

BEGINNING AT A POINT ON THE WEST LINE OF HARRISON BLVD.. SAID POINT BEING S.01°03'30"W.. ALONG THE SECTION LINE, 1162.46 FEET, AND N.89°02'00"W., 28.35 FEET FROM THE NORTHEAST CORNER OF SAID OUARTER SECTION. SAID POINT FURTHER BEING S.00°58'00"W.. ALONG THE CENTERLINE OF HARRISON BLVD., 545.70 FEET. AND N.89°02'00"W.. 50.00 FEET FROM THE OGDEN CITY SURVEY MONUMENT AT THE INTERSECTION OF 3300 SOUTH STREET AND HARRISON BLVD.. AND ON THE NORTH LINE OF 34TH STREET. AS EXTENDED EASTWARD FROM BRINKER AVENUE, AND RUNNING:

THENCE N.89°02'00"W., ALONG SAID NORTH LINE EXTENDED, AND ALONG THE EASTERN MOST NORTH LINE OF THE MIRADOR APARTMENT COMPLEX, 285.65 FEET, TO AN INTERIOR CORNER OF SAID COMPLEX:

THENCE N.52°29'00"E., ALONG A LINE OF SAID MIRADOR COMPLEX. AND CONTINUING ALONG THE SOUTHEAST LINE OF THE ST. PAUL'S EVANGELICAL LUTHERAN CHURCH PROPERTY, 161.59 FEET;

THENCE S.36°58'00"E.. 27.91 FEET; THENCE S.89°02'00"E., 142.00 FEET TO THE WEST LINE OF HARRISON BLVD.:


