

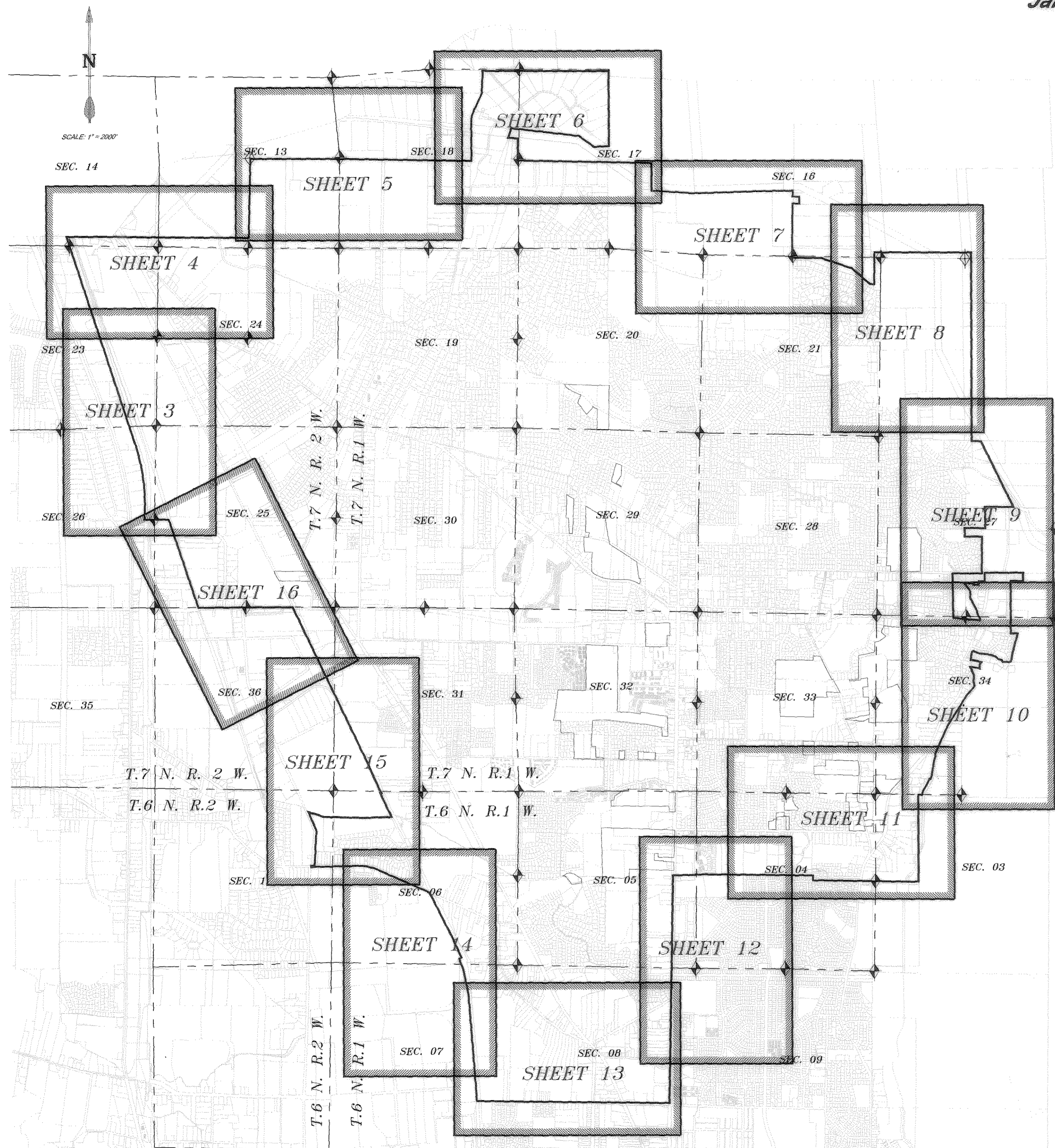
NORTH VIEW FIRE DISTRICT SUB-DISTRICT BOUNDARY

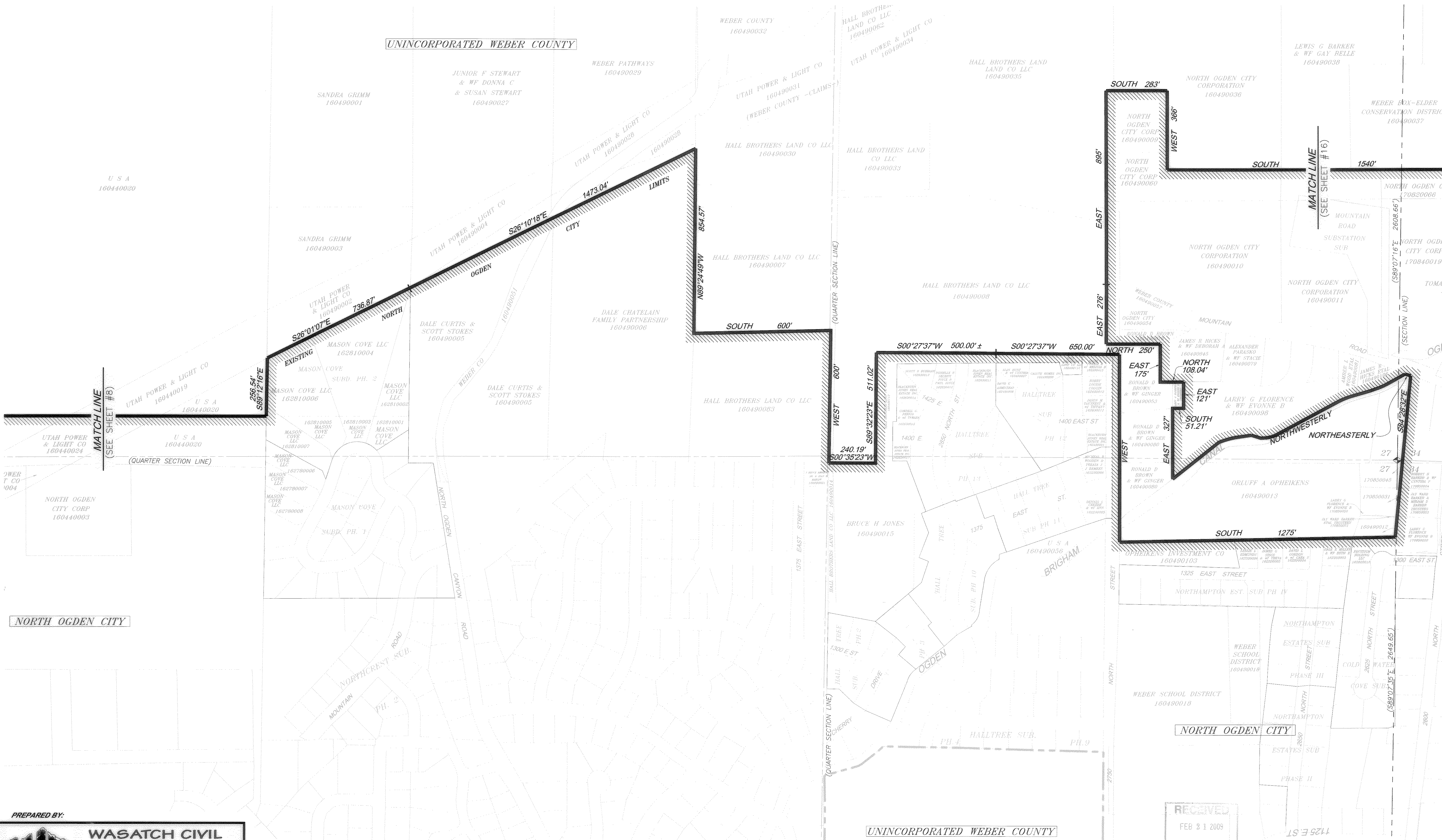
NORTH VIEW FIRE DISTRICT SUB-DISTRICT BOUNDARY
