

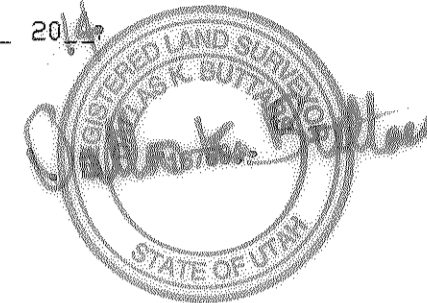

 PARCEL A HOUSE**

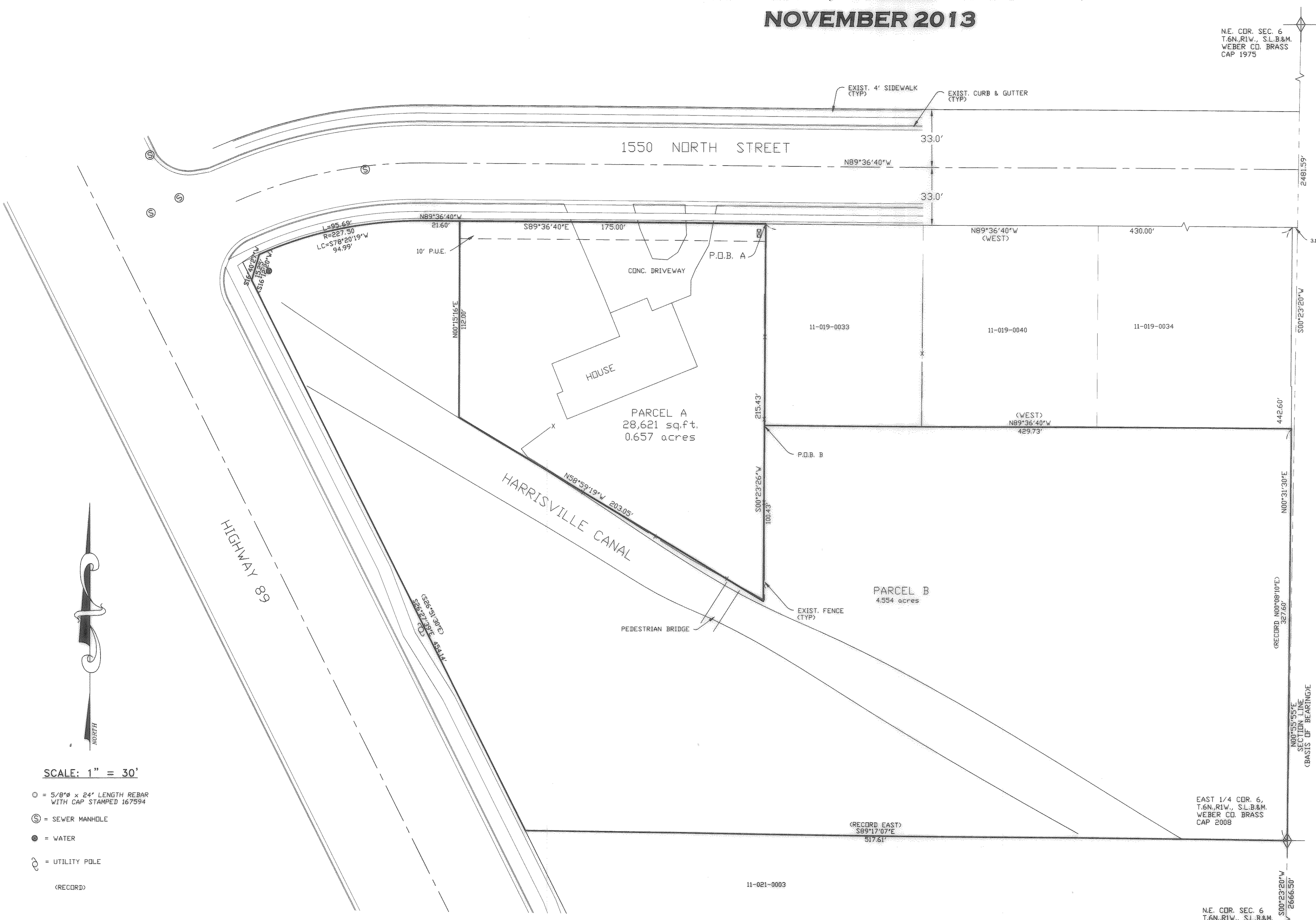
BASIS OF BEARING IS STATE PLANE GRID BETWEEN THE EAST QUARTER CORNER AND NORTHEAST CORNER OF SECTION 6.
 Part of the Northeast Quarter of Section 6, Township 6 North, Range 1 West, Salt Lake Base and Meridian;
 Beginning at a point being North 0°31'30" East 442.60 feet along the West line of Hunting Creek subdivision No. 7 to the South right of way of 1550 North street and North 89°36'40" West 430.00 feet along said South right of way from the East quarter corner of said section 6 and running thence South 0°23'26" West 215.43 feet; thence North 58°59'19" West 203.05 feet; thence North 0°15'16" East 112.00 feet to the South right of way of 1550 North street; thence South 89°36'40" East 175.00 feet along said right of way to the point of beginning, contains 0.657 acres

**BOUNDARY DESCRIPTION
 PARCEL B**

BASIS OF BEARING IS STATE PLANE GRID BETWEEN THE EAST QUARTER CORNER AND NORTHEAST CORNER OF SECTION 6.
 Part of the Northeast Quarter of Section 6, Township 6 North, Range 1 West, Salt Lake Base and Meridian;
 Beginning at the East quarter corner of said section 6 and running thence North 0°31'30" East 327.60 feet along the West line of Hunting Creek subdivision No. 7; thence North 89°36'40" West 429.73 feet; thence South 0°23'26" West 100.43 feet; thence North 58°59'19" West 203.05 feet; thence North 0°15'16" East 112.00 feet to the South right of way of 1550 North street; thence North 89°36'40" West 21.60 feet along said right of way; thence 95.69 feet along the arc of a 227.50 foot radius curve to the left (long chord= South 78°20'19" West 94.99 feet) to the Northerly right of way of Highway 89; thence South 16°40'27" West 15.25 feet; thence South 26°27'39" East 454.14 feet along said Northerly line of Highway 89; thence South 89°17'07" East 517.61 feet to the point of beginning, contains 4.554 acres

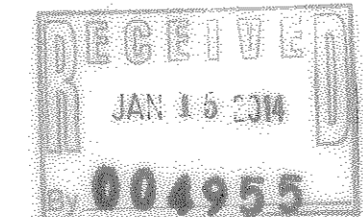
NARRATIVE

This survey was performed to create a smaller 1 lot parcel with the exist. home off of a larger parcel. The basis of bearing is State Plane grid N. 0°55'55" E. between the East quarter corner and N.E. corner of section 6, T. 6 N., R. 1 W., S.L.B.&M. The West line of Hunting Creek Subd. No. 1 was retraced and is not on the section line. The bearings are rotated to match the grid bearing base used.
