BEGINNING AT A POINT LOCATED ON THE NORTH RIGHT-OF-WAY LINE OF 4000 SOUTH STREET LOCATED NORTH 00°43'28" EAST 40.00 FEET AND SOUTH 89°57'56" EAST 915.45 FEET FROM THE SOUTHWEST CORNER OF SAID SOUTHWEST QUARTER AS MONUMENTED; RUNNING THENCE NORTH 00°02'04" EAST 619.93 FEET; THENCE SOUTH 89°16'32" EAST 412.09 FEET; THENCE SOUTH 00°43'28" WEST 295.91 FEET; THENCE SOUTH 34°52'02" WEST 168.09 FEET; THENCE SOUTH 33°59'25" WEST 220.07 FEET TO SAID NORTH RIGHT-OF-WAY LINE; THENCE ALONG SAID RIGHT-OF-WAY LINE THE FOLLOWING 2 COURSES, NORTH 89°20'46" WEST 133.10 FEET; THENCE NORTH 89°57'56" WEST 56.47 FEET TO THE POINT OF BEGINNING. NARRATIVE

THE PURPOSE OF THIS SURVEY WAS TO ESTABLISH AND SET THE PROPERTY CORNERS OF THE PARCELS SHOWN AND DESCRIBED HEREON. THE SURVEY WAS ORDERED BY ROGER STOKES. EXISTING WEBER COUNTY SURVEYOR MONUMENTATION WAS USED AS CONTROL AS WELL AS A BOUNDARY SURVEY OF THE OVERALL PARCEL DONE BY MOUNTAIN WEST SURVEYORS FOR WESTERN FARM CREDIT BANK. THE BASIS OF BEARING IS THE SOUTH LINE OF THE SOUTHWEST QUARTER AS MONUMENTED WHICH BEARS SOUTH 89°34'03" EAST.
