

NARRATIVE

THE PURPOSE OF THIS PLAT IS TO LOCATE ON THE GROUND THE BELOW DESCRIBED PARCEL OF LAND BEING WEBER COUNTY PARCEL NO. 07-081-0023.

AS-SURVEYED DESCRIPTION

PART OF THE SOUTHWEST QUARTER OF SECTION 22, TOWNSHIP 5 NORTH, RANGE 1 WEST, SALT LAKE BASE AND MERIDIAN, U.S. SURVEY.


DEEDS FOR PARCEL 07-081-0002 (ENTRY NO. 2482913) AND 07-081-0023 (ENTRY NO. 1339436) REFERENCE A DISTANCE OF 1030 FEET ALONG THE QUARTER SECTION LINE, FENCE LINE OCCUPATION IS APPROXIMATELY 1047 FEET, HOWEVER IF FENCE LINE HELD PARCEL 07-081-0002 WILL BE SHORT OF IT'S DEEDED 99 FEET. 







VICINITY MAP NOT TO SCALE
